#### Introduction / Background

1. At the 4th Extraordinary International Hydrographic Conference (4EIHC) in 2009 Member States approved a revised Strategic Planning Mechanism includingProgramme Performance Monitoring and Risk Management. The monitoring of programme performance monitoring will rely on a combination of strategic performance indicators (SPI's) and working-level performance indicators (WPI's)

- 2. During the 4EIHC the Directing Committee expressed a concern that the implementation of the strategic planning mechanism appeared to be complex and that it was unlikely that the existing capacity of the Bureau would be sufficient to undertake the detailed processes being proposed.
- 3. As a result, Decision 7 of the 4EIHC requested that the IHB Directing Committee review the implementation of the new planning mechanism, in consultation with the HSSC and IRCC chairs and report back to the next conference in 2012.
- 4. In 2010 HSSC-2 considered the proposed programme performance monitoring mechanism, particularly in relation to the IHO technical programme (Programme 2) and the work of the HSSC. HSSC-2 agreed that the WPI's presented at the 4EIHC were too numerous and many would be difficult to compile. HSSC-2 developed a simplified and pragmatic set of WPI's for consideration by the Directing Committee. These are presented at Annex A to this paper.
- 5. This Directing Committee presented a short progress report on the implementation of the strategic planning process to the XVIII<sup>th</sup> IHC in paper IHC paper CONF.18/WP.1/Add.2 *Implementation of the Strategic Plan*. The report indicated that some progress had been made, particularly in respect of development of the IHO Work Programmebut less progress had been made in implementing the performance monitoring and risk assessment mechanisms.

#### The Way Ahead

- 6. The Directing Committee reported that it will now move ahead and use the existing SPI's to monitor and report the achievement of the Objectives of the Organization, as they have been identified in Table 1 of Annex C of the Strategic Plan 2009. However, based on advice from the specialist expert provided by Norway and the practice and procedures followed by other international organisations and several Member States, the conclusion has been reached that the number and nature of the WPI's should be kept to a workable minimum.
- 7. In the next year, the Directing Committee will implement a periodical review of the achievement of the Objectives of the Organization based on the existing SPIs, using a standardized monitoring table (balanced scorecard), through which it will report to Member States.
- 8. At the same time, the Directing Committee will use the WPI's proposed by HSSC-2 as the basis to develop a similar monitoring and reporting process for the HSSC. This will include proposing methods to collect and collate the input data, setting tolerance levels and ways to report and present the results. This is expected to be available for review by HSSC-5 at its meeting in 2013.
