

Definition of Hydrography

Description of the IHO



Hydrography is the branch of applied sciences which deals with the measurement and description of the physical features of oceans, seas, coastal areas, lakes and rivers, as well as with the prediction of their change over time, for the primary purpose of safety of navigation and in support of all other marine activities, including economic development, security and defense, scientific research, and environmental protection.

To be the authoritative Worldwide Hydrographic Body

Mission

To create a global environment in which States provide adequate and timely hydrographic data, products and services and ensure their widest possible use

Object

Article II of the amended Convention



Planning and review cycles



- Strategic Plan: one year before IHC
- 5-year Work Programme: reviewed on a yearly basis

Ways and means

Risk analysis and mitigation

1. Identify the risks associated with each strategic direction in the SP

2. Estimate likelihood of occurrence and impact

3. Identify the range of mitigating actions required, responsible owners/stakeholders and priority/dates


