#### ADOPTION OF SPANISH CHART 7001 AS NEW INT CHART OF THE SCHEME FOR REGION M

To: Members of the IHO Hydrographic Commission on Antarctica (HCA)

Ref: a) HCA Letter 01/2010 dated 26 February 2010

b) HCA Letter 04/2010 dated 14 June 2010

Dear Sir or Madam,

Reference b acknowledged that the changes of limits and scale to INT 9121, which had been proposed by IHM Spain (see reference a), were accepted by HCA members. Reference b also included the following:

"In their response, South Africa suggested that IHM may consider proposing Spanish national chart IHM 7001 *Base Juan Carlos I* to raise INT status. While this appears to be a very sensible suggestion to the IHB, it is left to IHM to decide whether to proceed further on that matter."

Subsequently IHM wrote to the IHB, expressing their agreement as follows:

"I wish to state our full support of the suggestion from South Africa to adopt new Spanish chart no 7001 *Base Juan Carlos I* into the INT Chart Scheme. Please consider this letter as the formal proposal for adoption of the aforementioned chart into the INT Chart Scheme."

Details of the proposed new chart, which should be considered in conjunction with the revised INT 9121, are provided at Annex A. It is suggested that the INT number 9128 be given to the new chart, if approved.

You are requested to consider this proposal and provide your comments/approval **by 15 September 2010**, using the response form at Annex B.
