Dear Sir or Madam,

1. Proposed New INT Charts

As reported in paragraph 7.1 of the minutes of the 10th meeting of the Hydrographic Commission on Antarctica (HCA), announced by reference b), Ecuador, Australia and the United Kingdom proposed the inclusion of new INT charts in the scheme for Region M. It was agreed that these proposals should be circulated to all HCA members and observers for comments (Action HCA10/10 refers).

Details of the five proposed new INT charts by Ecuador, Australia and UK are provided at Annex A. INT numbers are suggested by the IHB as indicated. Location of the proposed new INT charts is shown in red colour on the indexes at Annexes B, C, D and E (taken from IHO publication S-11 Region M).

You are requested to consider this proposal and provide your comments/approval by 12 March 2011, using the response form at Annex F.

2. <u>INT 9128 (Spanish 7001)</u>

In same paragraph 7.1 of the HCA-10 minutes, it was also reported that the proposal in reference a) to adopt Spanish chart 7001 as new INT 9128, with Spain as producer, had been approved by HCA members. This chart has now been included in S-11 Region M on the IHO website (Action HCA10/8 refers).

3. Chart Production in Antarctica

The need for a comprehensive catalogue of all national charts produced in Antarctica was acknowledged at HCA-10, as reflected in paragraph 8 of the HCA-10 minutes. Such catalogue has been compiled at the IHB, based on the former publication S-59, the chart catalogues of producer nations and/or the HCA members' websites, and S-11 Region M, with update information kindly provided by

Argentina, Australia, Brazil, Chile, France, Spain and UK. Version 1.0.0 of this document has been posted on the HCA section of the IHO website, under 'Miscellaneous' (Action HCA10/29 refers).








ANTARCTIC PENINSULA, GRAHAM LAND – PALMER LAND Proposed New INT Chart 9117 (by UK)
