"8th Meso-american & Caribbean Sea Hydrographic Commission Conference" (MACHC)

Niteroi, Brazil, 8-10 October 2007.

1. Introduction and Welcome

The 8th Meeting of the Regional Hydrographic Commission of Meso-America and the Caribbean Sea was organized by of the Diretoria de Hidrografia e Navegação of Brazil and held at its premises in Niteroi.

Representatives from Barbados, Brazil, Colombia, Cuba, France, Guatemala, Mexico, The Netherlands, Norway, Suriname, UK, USA, IHB and commercial companies attended the meeting, that was chaired by Cdr Mario Góngora on behalf of Rear Admiral Del Angel (Mexico).

The host, Vice-Admiral Edgar Lawrence Mariath (Brazil) welcomed the participants and Capt. Gorziglia (IHB) thanked Brazil for hosting the meeting and stressed the increasing importance of the work of the Regional Hydrographic Commissions.

2. Administrative arrangements

Captain Cavalheiro explained the administrative details, local arrangements and social activities scheduled during the meeting.

3. Agenda and Time-table

The Agenda and Timetable were unanimously approved.

4. Chairman Report and Report of the 7th Meeting

The Chairman summarized the work carried out since the 7th meeting. He mentioned the need to amend the statutes to include a Vice-Chairman and other items that required updating, such as the limits of the Commission.

He also reminded that only four members of the Commission, Cuba, Mexico, Netherlands and UK had ratified the Amendments to the IHO Convention approved by the IHO Extraordinary Conference in 2005.

The report of the 7th Meeting was also tabled and approved without any further comments from the participants.

5. 17th I.H. Conference Decisions

Capt. Gorziglia summarized the results of the 17th IH Conference and presented the decisions related to the new structure of the organization. He stressed the formation of two main committees, to one of which, the IRCC, the Regional Hydrographic Commissions will report. He stressed the formation of two new Working Groups on Hydrography and Cartography of Inland Waters and on Marine Spatial Data Infrastructure Development and also referred to Decision 17 "Provision of Regional Staff Officers for Capacity Building Effort" highlighting the importance of having established a committee within MACHC to consider capacitybuilding issues and the nomination of a representation of MACHC at the CBC.

6. CBC Report

Capt. Gorziglia, in his capability of CBC Chairman presented a report on the activities of this Committee during the inter-sessional period, including the completed and pending activities related to the MACHC. He congratulated Mr. Doherty (USA) and Mr. Villalobos on their efforts to organize the MSI course in Jamaica and the Workshop on Development of Standard Operational procedures for Multibeam Hydrographic Surveys, respectively.

Capt. Cavalheiro, CBC member representing MACHC highlighted some pending activities such as high-level visits to Belize, Suriname, Dominican Republic and Honduras, the support to the "Gulf of Honduras" project, the course on ENC to be organized in Venezuela and the multibeam course to be hosted by Brazil.

Unfortunately, the Commission could not proceed conclusively in all the above mentioned matters due to the absence of Belize, Dominican Republic, Honduras and Venezuela.

The representative from US informed that the Director of the "Gulf of Honduras" project has changed and the procedure re-started after this change. The intention was to start hydrographic activity by the end of 2007.

The CBC Chairman referred to the MACHC projects considered in the 2008 Work programme for which the Committee has requested clarification and further information but has received no reply. The CBC Chairman strongly requested the Chairman of the Commission to take urgent action on this matter.

7. ISPWG Report

Capt. Cavalheiro, Vice-Chairman of the ISPW explained the progress of this working group, set up by the 17th IH Conference to re-draft the IHO Strategic Plan. Work has started by correspondence and nomination of representatives from RHCs has been requested. The Commission approved the nomination of Cuba as representative of the Commission in this WG.

He also reminded that the approval of a procedure to appoint representatives from MACHC in the future IHO Council was still pending. A working group with Cuba, Mexico, Netherlands and USA, with Brazil as Chairman was formed to address this topic and produce a draft document. A virtual forum to discuss MACHC matters will also be created (Brazil and USA).

8. Amendment of the Statutes

The statutes of the Commission had to be amended to include a Vice-Chairman with functions assigned and to adapt the limits of the Commission following the inclusion of Brazil as a new member in 2006 and the establishment of the new SWAtHC in 2007.

It was decided to create a Working Group with France, Mexico, UK, USA, with Brazil as Chairman to revise the statutres and to propose amendments. The final draft should be approved at the next meeting of the Commission.

9. Reports from the MACHC Committees

a) Reports from the INT Chart Committee and the Electronic Chart Committee were tabled.

The reports included information about the status of regional production of INT charts and ENCs.

These reports were endorsed by the Commission.

No report was submitted by the Commission's Capacity Building Committee (Chair:Venezuela)

b)The CPRNW Chairman, the representative of Guatemala and Mr. Villalobos presented reports respectively on the MSI Course held in Jamaica, the present status of the Gulf of Honduras project and the Multibeam Standard Operating Procedures Operational Workshop.Capt. Gorziglia thanked the efforts made by the institutions and individuals involved in the three projects/events and highlighted their importance for the development of hydrography world wide.

Colombia recommended continuing these activities with adequate funding provided by the CBC Fund.

c) The representative of the UKHO provided a report about Radio Navigation Warning Broadcast and a proposal from USA/NOAA on "International Marine Environmental Protection Products Specification was also considered by the Commission for its submission to CHRIS.

d) The representative of Land Surveys Association of Jamaica presented a report about the Workshop on National Spatial Reference Systems also held in his country.

10. New limits of the Commission

Following a proposal from Brazil and the previous agreement to extend zone B through C1 towards the equator, it was agreed to liaise with CHRIS to have the necessary changes made to the IHO publication M-11.

11. Proposal from ESRI

The observer from ESRI presented a proposal to establish a Stakeholders Advisory Group for MACHC. The Commission decided to consider the proposal that should be uploaded in the MACHC web site for study and conclusions of the members of the Commission.

12. Date and venue of the 8th MACHC Meeting

Due to the absence of the representatives from Venezuela, the confirmation of this country as the host for the 9th Meeting could not be achieved.

The Chairman will contact Venezuela and inform the Commission of the availability of this country. The representative of Suriname kindly offered to host the next meeting as an alternative.

The decision will be taken by the Commission at a later date.

13. Future Vice-Chairman

Brazil was nominated as the future Vice-Chairman of the Commission, following approval of the amendments to the Statutes.

14.- Closure.

Commander Mario Gongora in representation of the MACHC Chairman and the IHB Director, Captain Hugo Gorziglia made closing statements enhancing the achievements made and the tasks agreed. Finally Admiral Lawrence, Hydrographer of Brazil closed the meeting.
