The 19th Conference of the Mediterranean and Black Sea Hydrographic Conference (in reference) was the opportunity for the ICCWG Members to address most of current cartographic issues regarding their region during two side-meetings alongside the plenary MBSHC sessions. The positive feedback related to these side events led the Commission to agree about the possibility to arrange a half day ICCWG meeting back to back (prior) to the **20**th **MBSHC conférence** that will be held in **Montenegro** between **4**th **and 7**th **of July 2017** (action **MBSHC19/30**).

For the purpose of preparing that forthcoming session, it has been intended to convene a short extraordinary meeting of the Region F ICCWG on **Thursday 27 April** during the lunchtime break of the 1st Session of the IHO Assembly. This will enable ICCWG Members and Observers to meet briefly prior to the next MBSHC conference.

The proposed draft agenda for this special meeting is as follows:

- Status Report on the List of Actions from MBSHC-19;
- Outcomes from the 7th WENDWG meeting (29-31 January 2017);
- Organization of a Region F ICCWG half-day session alongside to MBSHC20 in Montenegro.
