# **Use of INT Chart Web catalogue (INToGIS)**

- > 2016: Entry into force of the International Chart Web catalogue and Web Manager (INToGIS project).
- > By using INToGIS web portal, ICCWG Members are able to:
  - >> update their INT charts,
  - >> visualize submitted INT chart proposals.
- Web manager account details already provided to:
  - CY, ES, FR, GE, GR, HR, IT, RO, TR, UA
- To receive your national account access details:
  - A-1: INToGIS helpdesk booth at the MS exhibition

# **MEDINTCHART restricted access webpage**

- <u>2006:</u> creation of a restricted webpage hosted and maintained by IHO Secretariat.
- 2016: launch of INToGIS web manager with national and regional secured accounts.

**Proposal:** maintain a **open access** Region F ICCWG webpage providing Member States with:

- >> Region F ICCWG ToRs and RoPs,
- >> full collection of region F ICCWG circular letters.

# **ENC overlaps risk assessment**

January 2017 – 7<sup>th</sup> WENDWG Meeting

WENDWG7/04: WENDWG endorsed the IC-ENC overlapping policy as a first step to identify navigationally significant overlaps and IHO Sec to make this policy available on the WENDWG Repository to be considered by RHCs.

WENDWG7/05: IC-ENC in liaison with Region F Coordinator to prepare a report on overlapping issues for the MBSHC as a trial.

- >> Use IC-ENC Master tracking database for all overlaps within the MBSHC region (IC-ENC risk assessment based analysis)
- >> ICCWG to qualify their effective risk level based on navigational criticity.
