Executive Summary:	In the framework of the Dover Strait survey strategy Working Group, this paper presents the Dover Strait survey strategy between FR, GB, BE and NL and discusses the interest to improve it and to merge the WG with the NSHC re-survey WG.

#### Summary

Since 1999 and in accordance with the 2000 agreement (ref. c), France has implemented the strategy to survey sand dunes in the Dover Strait area as defined in the letter in reference a). This work included:

- a systematic survey of the area over 10 years,

- annual monitoring of the most dangerous dunes.

All these works were performed and regularly analyzed by specialists of the dynamics of sand wave through modeling studies on the mobility of dunes.

Accordingly, SHOM proposed to the NSHC successively at its 29th meeting in 2010 and lately at its 30<sup>th</sup> meeting in 2012 an evolution of that strategy, effective since 2013:

- surveys will be conducted within waters under French jurisdiction, consistent with the legal responsibilities of States,

- areas with no recent bathymetric data will be surveyed to obtain an updated knowledge of the area, to detect the presence of wrecks and detect the arrival or birth of dunes,

- the most dangerous dunes will be surveyed every two years.

Those elements making obsolete the quadripartite agreement in reference (b), a new draft agreement was brought to the attention of the NSHC at its  $30^{th}$  conference in 2012 by France. This draft was supposed to include in fine the following details regarding the different parties and their common strategy :

- the geographical limits of the agreement, the same as in the 2000 agreement, and surveys limits coincide with the limit of waters under national jurisdiction,

- monitoring of the agreement made at each meeting of the NSHC (national report),

- the requirement to transmit to one State data collected by another State in waters under the jurisdiction of that State and within the limits of the agreement,

- the reference to technical provisions of each state (for instance the French hydrographic instructions).

Therefore, one of the 30<sup>th</sup> conference conclusions (#102) was stated as for the concerned member states to provide their comments and remarks regarding the draft agreement provided by France, and to attach to their feedback their technical provisions. Following up that decision, a letter was sent to all

concerned member states in July 2012, which lead to the providing of the technical provisions by the parties.

# Analysis

Taking into account the information provided through national technical provisions, the national strategies are summed up in the following table.

A resurvey strategy covers currently the Dover Strait. However, it is questioned whether it should be, more than a compilation of national strategies:

- a) worked out to be homogeneous in respect of the maritime traffic and the physical processes in the area,
- b) completed to describe relations between the HOs (on exchange of information on sand dunes which cross frontiers, etc).

This global strategy should be published, through an agreement or, if estimated too difficult to achieve (for juridical reasons for example), by another means (NSHC website, ...).

Considering that the subject of marine sand dunes and re-surveys deals with scientific aspects that could be of interest for other countries that the 4 involved in the DSS WG, the need to deal with it directly in the NSHC resurvey WG (and so to remove the DSS WG) could be discuss at the NSHC31.
