#### NSHC LETTER No 02/2016

Dear Colleagues,

This letter addresses an issue to be discussed during the 32<sup>nd</sup> NSHC Conference in June: the procedure for selecting the NSHC representatives to the IHO council. This procedure is requested by the IRRC. Action IRRC7/26 applies: "Report to IRCC on the status of the RHC procedures for selecting their respective representatives to the Council". In this letter I will present a proposal for a new Annex to the NSHC Statutes including a flow chart for this selection procedure (Enclosure 1). A similar Annex already has been adopted by the Meso American and Caribbean sea Hydrographic Commission (MACHC) at the 16<sup>th</sup> Conference.

The representatives in the IHO council will be approved by the first assembly of the IHO once the "Protocol of Amendments to the convention on the IHO (November 2005)" is ratified. The functions of the new IHO council are described in this protocol. They are amongst others.

- co-ordinate, during the inter-Assembly period, the activities of the Organization within the framework of the strategy, work program and financial arrangements, as decided by the Assembly;
- prepare, with the support of the Secretary-General, proposals concerning the overall strategy and the work program to be adopted by the Assembly.

Two-thirds of Council seats (20 seats in the current configuration) shall be held by Member States selected by the Regional Hydrographic Commissions (RHCs). The remaining one-third of Council seats (10 seats in the current configuration) shall be held by Member States that have the greatest interest in hydrographic matters and have not been selected by the RHCs.

The selection process for seats was considered at the 5th Extraordinary International Hydrographic Conference in Monaco. The Conference agreed Decision No 6 which provides guidance on the process by which the Secretary-General shall allocate the number of seats on the Council to each RHC.

The RHCs must now decide on a procedure for allocating these seats to its Member States. In Enclosure 2 more detail is provided in IHB letter S1/6200. Firstly, it describes the preliminary process for the determination of the number of seats on the Council allocated to each Commission. Secondly it describes a set of generic rules that RHCs may wish to use as the basis of a procedure for the designation of their representatives.

I took the generic rules as a baseline and worked it into the Annex to the Statutes with two main adaptations.

- For voting I removed the required quorum of 2/3 of the Member States (paragraph 7). It could be procedurally difficult to achieve this quorum, complicating effective decision making. Moreover, the current voting procedure for other (statute) matters does not require such a quorum.
- I used the wording agreed within the MACHC for the way in which the selected Member States carry out their role as NSHC representatives (paragraph 3). Three of the NSHC members are also MACHC members.

Subject to the ratification of the Protocol, the first Assembly is planned to convene from 24 to 28 April 2017. I anticipate that the Secretary-General will initiate the selection process for the establishment of the Council before the 33<sup>th</sup> NSHC meeting. Therefore the NSHC must have an agreed procedures before that date.

I invite you to study this proposed procedure including the flowchart (Enclosure 1) with the aim to make a decision at the upcoming NSHC meeting.

#### **ANNEX A to the STATUTES of the NSHC**

# PROCEDURE FOR THE DESIGNATION OF NSHC REPRESENTATIVES TO THE IHO COUNCIL

Designation of NSHC representatives to the IHO Council shall be determined in compliance with IHO General Regulations Articles 2 and 16.

## Role and Authority of Representatives to the NSHC in the Council

- 1. IHO Member States representing the NSHC, shall occupy their seat on the Council for all sessions of the Council throughout the inter-sessional period between Assemblies.
- 2. All expenses connected with the participation of representatives to the Council shall be defrayed by their respective State, in accordance with IHO General Regulation Article 3.
- 3. In carrying out their role as a representative of the NSHC to the Council, the elected Member States shall take into account the views of the Member States of the Commission. A standing agenda item during the NSHC Conferences will cover IHO Council matters.

### **Selection Procedure (see also flowchart Appendix 1)**

- 4. Three months before an ordinary session of the Assembly, the Secretary-General shall inform the Chair of the NSHC of:
- a. the number of seats allocated to the NSHC, and
- b. those Member States that are eligible for selection by the NSHC.
- 5. If the number of Member States eligible for selection to represent the NSHC to the Council is equal to the number of seats on the Council assigned to the NSHC by the Secretary-General under the terms of clause 4 above, then the aforementioned eligible Member States will be designated as representatives of the NSHC.
- 6. If the number of Member States eligible for selection to represent the NSHC to the Council is greater than the number of seats assigned to the NSHC by the IHO Secretary-General under the terms of clause 4 above, then the Chair of the NSHC will invite those Member States that have been designated as eligible for selection to the Council to indicate if they wish to be considered as candidates for selection.
- a. If the number of candidate Member States is equal to the number of number of seats on the Council assigned to the NSHC, then these candidate(s) will be designated as representatives of the NSHC.
- b. If the number of candidate Member States is smaller than the number of seats on the council assigned to the NSHC, the candidate(s), if any, will be automatically designated and will be complemented by the eligible Member State(s) that have not been representatives of the NSHC to the Council for the longest time. If this proves inconclusive, the Chair will designate eligible Members State(s) as representative of the NSHC.
- c. If the number of candidate Member States is greater than the number of seats on the council assigned to the NSHC, the candidate(s) to represent the NSHC to the Council will be designated through a voting procedure.

#### **ANNEX A to the STATUTES of the NSHC**

### **Voting Procedure**


- 7. The voting procedure will take place in the three months prior to the Assembly, preferably at a Conference of the NSHC otherwise by correspondence if no NSHC Conference is scheduled.
- a. Each Member State may submit one voting paper marking as many candidate Member States from the list as seats have been assigned to the NSHC (see example of voting paper in Appendix 2).
- b. The quorum for a valid voting procedure is set at 50% of Member States casting their vote. Representatives of the NSHC to the Council are then elected by simple majority. An incomplete or blank voting paper is a valid voting option and does not count against the quorum.
- c. If no quorum is achieved, the voting window is extended for two weeks and the chair invites the missing Member States to cast their vote. The existing votes stand.
- d. If still no quorum has been achieved, the chair designates the representatives of the NSHC to the Council based on the votes cast. In case of a draw the candidate that has not been a representative of the NSHC to the Council for the longest time is designated as representative of the NSHC. If this proves inconclusive the Chair will designate a candidate as representative of the NSHC.

## Manning of the representatives

- 8. The Member States selected to represent the NSHC in the Council are normally represented by the head of the Hydrographic office. Each Member State shall inform the Chair of the NSHC and the Secretary-General of the IHO of the name of its official representative. An alternate may also be designated.
- 9. Member States representing the NSHC shall inform the Chair of the NSHC and the Secretary-General of any changes in representation, whether permanent or temporary, as soon as practicable.

# PROPOSED PROCEDURE FOR REGIONAL HYDROGRAPHIC COMMISSIONS TO DESIGNATE THEIR REPRESENTATIVES TO THE IHO COUNCIL

#### References:

- A. General Regulations of the IHO (not yet in force);
- B. IHO Publication P-6 EIHC-5 Report of Proceedings Decision No 6 PRO3 (Council selection process)

### Chairs of the Regional Hydrographic Commissions

#### Dear Chairs,

- 1. In accordance with the General Regulations of the IHO that will enter into force once the Protocol of Amendments to the IHO Convention is ratified, the list of the members of the IHO Council will have to be approved by the first Assembly of the IHO. Two-thirds of Council seats (20 seats in the current configuration) shall be held by Member States selected by the Regional Hydrographic Commissions (RHCs). The remaining one-third of Council seats (10 seats in the current configuration) shall be held by Member States that have the greatest interest in hydrographic matters and have not been selected by the RHCs (see Reference A).
- 2. Triggered by a proposal submitted by the USA, the selection process was considered at the 5<sup>th</sup> Extraordinary International Conference. The Conference agreed Decision No 6 which provides guidance on the process by which the Secretary-General shall allocate the number of seats on the Council to each RHC (see Reference B).
- 3. A number of RHC have initiated consideration of the process by which they will select, and possibly instruct, their representatives in the Council. Taking into account the process which has been agreed by the Mediterranean and Black Seas Hydrographic Commission as an annex to its Statutes and noting that other Commissions have indicated that they would welcome further guidance, the Directing Committee offers for your consideration a generic template outlining:
  - a. the preliminary process for the determination of the number of seats on the Council allocated to each Commission (see Annex A), and
  - a set of generic rules that RHCs may wish to use as the basis of a procedure for the designation of the representatives of each Commission in the Council (see Annex B).
- 4. Article 16 of the new General Regulations of the IHO (not yet in force) provides for the replacement of a member of the Council only in the event that a Member State holding a seat on the Council should be denied voting rights and benefits in accordance with Article XV of the Convention

as amended. Consequently, in any other case where a selected Member State is unable to be represented in a session of the Council or is unable to continue to represent an RHC for any other reason, no replacement is possible until the selection of a new Council at the end of the next ordinary session of the Assembly.

- 5. Subject to the ratification of the Protocol of Amendments by the required two-thirds majority in time for the first Assembly to be convened from 24 to 28 April 2017, the selection process for the establishment of the Council will be initiated by the Secretary-General not later than October 2016. Therefore it is expected that all RHCs will have agreed on their specific arrangements before that date.
- The Directing Committee stands ready to provide additional advice as may be required.

# PRELIMINARY PROCESS FOR THE DETERMINATION OF THE NUMBER OF SEATS ON THE IHO COUNCIL ALLOCATED TO EACH RHC

The number of seats allocated to each Regional Hydrographic Commission (RHC) on the IHO Council and the list of Member States eligible for selection by each RHC shall be determined in compliance with IHO General Regulations Article 16 and Decision No. 6 of the 5<sup>th</sup> Extraordinary International Hydrographic Conference.

- Prior to six months before an ordinary session of the Assembly, the Secretary-General of the IHO will invite all IHO Member States that are full members of more than one RHC to indicate for which RHC they prefer to be counted for the purpose of determining the composition of the Council.
- Taking into account the composition of the RHCs at the time, the Secretary-General will firstly seek input from IHO Member States that are full members of more than one RHC regarding the RHC in which they prefer to be counted for the purpose of determining the composition of the Council. This process will be carried out as follows:
  - a. The Secretary-General will ask the full members of those RHCs that comprise only members that are also full members of one or more other RHCs (currently, the members of the Arctic Regional Hydrographic Commission, the Nordic Hydrographic Commission and the US/Canada Hydrographic Commission) to declare their choice of the RHC for which they wish to be counted for the purpose of determining the composition of the Council;
  - b. The Secretary-General will then ensure that at least one candidate is available to represent the aforementioned RHCs.
  - c. The Secretary-General will then inform the other Member States that are full members of more than one RHC (currently, certain members of the Eastern Atlantic Hydrographic Commission, the Southern Africa and Islands Hydrographic Commission, the South-East Pacific Regional Hydrographic Commission and the South-West Atlantic Hydrographic Commission) of the identity of the States and the RHCs determined under the process described in sub clauses 2.a and 2.b and seek their choice of the RHC for which they wish to be counted for the purpose of determining the composition of the Council.
- 3. In the event that a Member State that is a full member of more than one RHC fails to declare its choice, the Secretary-General will count that Member State in the RHC to which the Member State joined first as a full member. If this criterion is not selective, then the Secretary-General will count the Member State in the RHC with the smallest number of full members.
- 4. Three months before an ordinary session of the Assembly, the Secretary-General shall take into consideration the submissions required under the terms of clause 2 above and the over-riding need to ensure that:
  - every Member State is counted as a full member of one, but not more than one, RHC.
  - a sufficient number of Member States are designated as eligible in each RHC so as to ensure that all RHCs can be represented in the Council,

and inform the Chairs of the RHCs of:

- a. the number of seats allocated to each RHC, and
- b. the list of Member States that are eligible for selection by each RHC.

# RULES FOR THE DESIGNATION OF [xxRHC] REPRESENTATIVES TO THE IHO COUNCIL

Designation of [xxRHC] representatives to the IHO Council shall be determined in compliance with IHO General Regulations Articles 2 and 16.

# Role and Authority of Representatives to the [xxRHC] in the Council

- 1. IHO Member States representing the [xxRHC], shall occupy their seat on the Council for all sessions of the Council throughout the inter-sessional period between Assemblies.
- 2. All expenses connected with the participation of representatives to the Council shall be defrayed by their respective State, in accordance with IHO General Regulation Article 3.
- 3. In carrying out their role as a representative of the [xxRHC] to the Council, representatives shall take note of any relevant collective decisions, policies or directives established by the [xxRHC] and ensure that these are considered appropriately by the Council.

#### **Selection Procedure**

- 4. Three months before an ordinary session of the Assembly, the Secretary-General shall inform the Chair of the [xxRHC] of:
  - a. the number of seats allocated to the [xxRHC], and
  - b. those Member States that are eligible for selection by the [xxRHC
- 5. If the number of Member States eligible for selection to represent the [xxRHC] on the Council is equal to the number of seats on the Council assigned to the [xxRHC] by the Secretary-General under the terms of clause 4 above, then the aforementioned candidates will be automatically designated as representatives of the [xxRHC].
- 6. If the number of Member States eligible for selection to represent the [xxRHC] in the Council is greater than the number of seats assigned to the [xxRHC] by the IHO Secretary-General under the terms of clause 4 above, then:
  - a. the Chair of the [xxRHC] will invite those Member States that have been designated as eligible for selection to represent the [xxRHC] in the Council to indicate if they wish to be considered as candidates for selection.
  - b. if the number of candidates is not greater than the number of seats assigned to the [xxRHC], the representatives will be designated by the Chair of the [xxRHC] from the candidates, if any; and then, as appropriate, giving preference firstly to the remaining Member States that are eligible and have never been representatives on the Council before and secondly to those that have not been representatives on the Council for the longest time.
  - c. if the number of candidates is greater than the number of seats assigned to the [xxRHC] a vote will take place at a Conference of the [xxRHC], or by correspondence if no [xxRHC] Conference is scheduled in the three months prior to an Assembly. Each Member State may submit one voting paper listing as many Member States from the list of candidates as seats have been assigned to the [xxRHC]. The result of a vote will only be valid if at least two thirds of all [xxRHC] Member States are present or have voted by correspondence in due time.

- d. The Member State(s) with the greatest number of votes will be designated as the [xxRHC] representatives in the Council. In the case of a draw, the Chair of the [xxRHC] will cast a deciding vote.
- e. If the result of the vote is invalid, the representatives will be designated by the Chair of the [xxRHC] giving preference firstly to the candidates that have never been representatives on the Council before and secondly to those that have not been representatives on the Council for the longest time.

# Designation of the representatives

- 7. The Member States selected to represent the [xxRHC] in the Council are normally represented by the head of the hydrographic office. Each Member State shall inform the Chair of the [xxRHC] and the Secretary-General of the IHO of the name of its official representative. An alternate may also be designated.
- 8. Member States representing the [xxRHC] shall inform the Chair of the [xxRHC] and the Secretary-General of any changes in representation, whether permanent or temporary, as soon as practicable.
