# 3<sup>nd</sup> SAIHC INT CHART COORDINATION WORKING GROUP (ICCWG) MAPUTO: 11 AUGUST 2014

# Agenda Item 1: Opening and Administrative Arrangements

Captain Abri Kampfer, the Chairman, welcomed all participants to the 3<sup>rd</sup> ICCWG meeting and a thanked to INAHINA for hosting the meeting. In his opening remarks, the Chairman indicated the importance of this working group and its role within the SAIHC community and that those regional members who participate could benefit much from attending this meeting as it provides an opportunity to communicate specific requirements and charting priorities to the INT Chart producer responsible for chart production of their country.

## Agenda Item 2: Approval of Agenda

All members present approved the Agenda.

### Agenda Item 3: Supplementary Items

The Chairman informed the meeting that South Africa had tabled three additional items for discussion at a later point in the proceedings, namely:

- Mozambique Catalogue;
- Chart Printing Format; and
- Report to SAIHC Conference

# Agenda Item 4: Matters arising from Minutes of 3st ICCWG Meeting

Action Item 1: Inform Chairman and UK of decision on proposal by UK for PT to become sole producer of INT 2089 although indications are that co-production should continue.

It was agreed that PT and UK co-produce this chart. (Item closed).

Action Item 2: Raise request for supply of data between MS timeously, for updating of INT charts on SAIHC 10 meeting.

Chairman informed that no additional data had been forthcoming. Chairman to raise this matter in his report back on this meeting at the SAIHC Conference (Action Item 1).

#### Action Item 3: Decision pending by MZ to co-produce INT 7052.

MZ informed the Chairman that they are currently working on acquiring the coastline and portside information. PT and ZA confirmed their co-producer status; MZ to confirm (Action Item 2).

# Action Item 4: MZ to consider a metric chart of Approaches to Beira.

MZ informed the meeting that they were at an advanced stage in producing their national chart of Beira approaches, having updated the bathymetry and topography. It was agreed that UK assist MZ in this work as a co-producer, which would ensure the chart could be given INT status (Action Item 3).

Action Item 5: ZA to circulate S-11 Part H to all members. Members to provide further inputs to S-11 Part B Area H to the Chairman by 31 October 2013.

Done. Further updating to be done during standing item on agenda. Item closed.

# Action Item 6: UK to inform the Chairman on how the gap in INT small scale charting north of Madagascar can be resolved.

UK informed the Chairman that their office did not view this as a priority matter so no action will be forthcoming in the foreseeable future to address this deficiency. UK requested this item remain open as an action item on UK (Action Item 4).

Action Item 9: Mauritius to the carry out a comparison between the INT Charts and their national charts and inform UK if there are significant differences.

Item closed as this can be resolved through existing bilateral arrangements between the countries concerned.

# Agenda Item 5: Standing Items

### 5.1 S11 - Region H Chart Scheme

Changes to S-11 Part B Region H were included by ZA prior to the meeting based on national reports received and a recent visit to SANHO by INAHINA. The following changes were noted and decisions were taken:

Amend IN to read IND in list of printer nations in *column 13*.

Establish national chart numbers for printer nations in *column 13*.

Amend printer date GB (4134 - 02) to read GB (4138 -12) (column 13).

#### **INT 2672**

ZA produced a new edition in 2014.

#### **INT 7050**

Remove PT and MZ as producer nation in *column 2*.

#### INT 7052

Amend MZ? To read MZ in *column 2* (producer nations). ZA to take the lead on producing this chart. (Action 5).

#### INT 7063

New INT chart published in 2014. Insert 14/ in column 9.

#### INT 7560

UK produced national chart GB 4171 in 2013.

#### INT 7533

ZA produced a new edition in July 2014. UK planning to release GB 4160 in 2015.

#### INT 7561

Amend printer date GB (4170 - 07) to read GB (4170 -11) (column 13)

#### <u>INT 7563</u>

New edition scheduled for publication in 2015.

#### INT 7580

Remove GB as producer nation column 2.

Amend GB 2930 to read (GB2930) column 3.

#### INT 7582

Include GB as producer nation *column 2*. UK to take co-responsibility for producing this chart; PT to assist.

#### **INT 7631**

Insert (GB2759) in column 2.

#### <u>INT 7632</u>

UK and MZ to discuss production of this chart. (Action Item 6)

Insert (GB2758) in column 2.

Amend GB 642 to read (GB 2758) in column 3.

Insert published date (13) in column 9.

### NEW INT CHART 7645 of Porto da Topuito based on MZ 16307

MZ and PT to co-produce. Include details in S11 Part B. (Action Item 7)

#### **INT 7710**

Confirm published date of this chart with FR (13 or 14?). (Action item 8)

UK to confirm national chart number and printed date (column 13). (Action item 9).

# **INT 2655**

Amend 94/ to read 94/12 column 9.

#### Miscellaneous:

UK informed the Chairman that GB 3878 and 3880 have been drawn to INT chart limits and confirmed that GB 659 could be an INT chart. INT number 2513 duly assigned to this chart. (Action 10)

New national charts and new editions (reported in FR National Report) - 7680, 7492, 7493 and 7494 – should these have INT chart status/ which of these are

FR adopted INT charts?

It was suggested to include ENC coverages and production data in S-11 Part B. IHB to raise this item with CSCPWG. (Action 11)

# 5.2 Status of INT Charting

New editions of INT 7531 Approaches to Port Elizabeth, 7532 Port Elizabeth Harbour, 7562 Durban Harbour, INT 7561 Approaches to Durban and 7563 Durban SBM. ZA reported that new editions were being planned based on new multibeam survey data and buoyage changes. The production of the new chart INT 7563 is in an advanced stage of production.

<u>Production of INT 7583 Port of Maputo.</u> MOZ provided a new version of national chart MZ 16401 Port of Maputo (currently in production) which they felt provided better coverage than the existing INT chart 7582. It was decided that UK also become a producer nation with PT assisting UK and MZ. Due to extensive change of coverage existing INT 7582 to be replaced by the next chart number which will be INT 7583. Chairman to inform IHB of INT number allocation (**Action item 12**).

<u>Production of INT 7739 Port Louis, Mauritius</u>. The Chairman informed the meeting on the correspondence that took place with India and stated that the only INT chart under consideration was the one covering Port Louis (IN 2514) which is being produced by India. INT number 7739 assigned to the new chart and INT 7738 to be cancelled. Mauritius to inform India of assigned INT number and to inform Chairman when this chart is ready for publication. (Action 13) Chairman to inform IHB of INT number allocation (Action item 14).

<u>Production of INT 7581 Bay of Maputo.</u> UK to discuss production with MZ (Action item 15).

<u>INT 7661 Nacala.</u> Based on information from Malawi on port developments (which should be completed in about 2 months time) and the requirement to give this important export harbour for States in the region INT status, it was agreed to produce a harbour and approaches chart covering this port. Feasibility of one chart containing two panels or two charts, harbour and approaches to be determined.

MOZ proposes national chart MOZ 16310 as a 1/20T Port of Nacala chart instead of plan. If accepted allocate INT 7662 to this chart otherwise allocate additional number. PT/MZ to inform Chairman of decision regarding use of one or two charts for INT number allocation purposes (Action Item 16).

INT 7631 Approaches to Beira. UK and PT to be involved for production of first INT chart version. Charts GB 2758 and MZ 16303 to be compared (See Action Item 3).

NEW INT CHART 7645? Porto da Topuito based on MZ 16307. MZ and PT to discuss the production of this chart (See Action Item 7).

NEW INT CHART 2513 Soyo based on GB 659 chart. It was agreed to allocate INT number 2513 to this chart (See Action Item 10).

#### 5.3. Comparison of INT Charts vs ENCs

ZA and UK to produce a presentation to SAIHC meeting (Action Item 17).

It was noted from FR national report that France produced an ENC FR 476820 and GB has an ENC GB400688. The former uses the name Toamasina and the latter Tamatave. As no two ENCs may be produced of the same area in the same usage band how does this impact on these two products. GB and FR to provide clarification of naming and data coverage (Action Item 18).

### 6. Any Other Matters Arising from Discussions during the Meeting

<u>Mozambique Catalogue.</u> Chairman informed meeting of visit by INAHINA and discussions arising out of their new chart catalogue. It is important for MZ to note that the INT and national chart must have the same limits.

<u>Printing Format.</u> ZA informed the meeting of their experience in restricted image area of DE size (1040 x710mm) when printing a chart having an A0 format. A review of MZ charts in their catalogue revealed that 18 of their charts may not print within an A0 format on an AO lithographic printer. If the intention is to continue to print on demand, it is not an issue.

The question of data acquisition from national port authorities was raised by MZ and discussed. MZ was urged to contact Jeff Bryant to obtain the document produced by the UKHO (Provision of Hydrographic Information, A Code of Practice for Ports and Harbours, International Edition) and adapt it so that an agreement detailing the format of information and what information should be supplied can be drawn up with relevant Port and other institutions. This will contribute to the chart reflecting reality. The chairman recommended discussions with role players and use examples of past incidents to sensitize the data owners to the question of liability and responsibility. UK to provide MZ with a copy of this Code of Practice document (Action Item 19).

# Agenda Item 8: Date and Venue of next meeting

Date and venue will be confirmed at the 11<sup>th</sup> SAIHC conference. Mauritius has confirmed that their offer to host the meeting still stands.

# Agenda Item 9: Closure

There being no further business to discuss, the meeting was formally declared closed by the Chairman at 12:00 to allow members to participate in the tour arranged by INAHINA.
