IMO Audit

IMO, as a specialized agency of the UN, has the responsibility to develop universal technical safety, security and pollution prevention standards relating to ships and shipping activities. Governments have the duty to implement and enforce these standards;

A universal approach had to be developed to review governments role in the implementation and enforcement of international shipping treaties. Thus, the Voluntary IMO Member State Audit Scheme could serve as the vehicle to establish and improve accountability amongst Member States of IMO with respect to their treaty(s) obligations.

IMO SG said: "rather than causing embarrassment to those to be audited by exposing their weaknesses, would instead bring both sides closer together - the one helping the other in pursuit of the common goals of enhanced safety and environmental protection."



IMO Audit

October 2005, IMO decides to create a Voluntary Audit Scheme for IMO Member States. Member States could ask IMO to verify they are compliant with statutory instruments as SOLAS Chapter V rule 13. Reference : IALA Guidelines N° 1054 and 1055

Since 1st January 2016 the Audit Scheme will become mandatory (IMO Resolution A.1018(26), 26th Assembly).

The National Authorities will then been audited, in accordance with a seven years calendar

IMO Member State Audit Scheme (IMSAS)

Voluntary from October 2005, it is now mandatory since 1st January 2016.


It includes conformity with SOLAS, COLREG, LL, MARPOL, STCW and Tonnage
