#### **Executive Summary**

This is the 10<sup>th</sup> year for the UKHO to deliver its International Hydrographic Organisation (IHO) Category B accredited programme, Marine Cartography and Data Assessment in support of the International Hydrographic Organisation Nippon Foundation Chart Project. This report summarises the outcomes of the delivery of the 2018 course, and makes recommendations to enhance future delivery.

The selection of candidates for this course was made in April 2018 at IHO Secretariat premises, by representatives from the IHO, JHOD and UKHO. The course received 28 applications from 27 nations, of which 7 fellows were selected.

The 16-week course is an intense programme, requiring significant commitment from all parties. It was also important, and a key element of the selection criteria, that all participants would be able to utilise the skills gained following the course.

The selection criteria and process has again proved to be rigorous with the selection of delegates from Brunei Darussalam, Croatia, Indonesia, Pakistan, The Philippines, Poland and Sri Lanka who were joined by additional fellows from JHOD, Romania and Malta. The fellows quickly demonstrated their commitment, aptitude, camaraderie and willingness to learn very early on, and that continued until the last day. All of the fellows worked in a diligent manner to achieve and exceed the standard required of the category B course. All fellows successfully completed the course.

Recommendations from previous courses have also been implemented and the feedback received has proved to be positive. Pre-course learning material was issued prior to the course, which was appreciated by the delegates. The structure of the course puts the emphasis on compiling electronically within a hydrographic database to reflect the way most HO's function.

The NIPPON fellowship is an important element of this program and will enhance knowledge sharing and networking in support of the NIPPON aim of developing an international human resource network.

This course has proved to be another success. All participants should be congratulated on their achievement. Lessons have been learnt and will be applied where necessary. However, considering the commitment and organization required, this course has been a pleasure to be involved in, and all parties are thanked for their contribution and support.

This is truly an international collaboration and supports the ethos of the IHO Secretariat in developing capacity, improving standards, and in developing an international cartographic community to enable continuous professional development. This year's alumni must be congratulated on how quickly they bonded together as a group supporting each other both academically and socially. The interactions and bonds they developed with each other I am sure will last a lifetime.

#### 1. Background

The announcement of this course was made via IHO Secretariat Circular Letter inviting organisations to nominate individuals who would benefit from marine cartographic training and who would be able to apply the skills learnt within their respective organizations following the intense programme.

It is gratifying to report that the demand for this prestigious course continues with twenty-eight applications from twenty-seven nations received. The selection process resulted in seven individuals being selected to attend the International Hydrographic Organisation Nippon Foundation Chart Project programme. Mr Nagasaka from the IHO had put much effort into developing a fair and comprehensive set of selection criteria, the salient ones being – good English both written and spoken, no repeat selections for at least a year, a future career in cartography is mandatory, a 'train the trainer' approach was deemed worthy of higher consideration, at least 15 years working life before retirement and no 'training tourists' – people who just train for the sake of their CV – the training must be utilised.

#### 2. The course

The course delivered was the UKHO Marine Cartography & Data Assessment (MCDA) course, this course is internationally accredited by the IHB/FIG/ICA Board at the Category B level of the S-8 Standard for Nautical Cartographers. The course is delivered in 4 Modules and a Final Project containing the subjects: pre-learning book, foundation, compilation, product construction, data assessment.

The course commenced on September  $3^{rd}$ , 2018 and concluded on December  $14^{th}$ , 2018.

The course was formally opened by Captain Derek Rae, UK Deputy National Hydrographer.

#### 3. Administration

All administration was carried by the UKHO training team administrator. All selected delegates were sent detailed Joining Instructions, informing them of accommodation, flights, visa and security arrangements.

#### 4. Course Outcomes/Results.

#### 4.1 Course Aims and objectives

The course aims are to provide a sound introduction to the techniques and responsibilities of processing hydrographic data into published and digital form. Concentrating on nautical charts, it lays the foundation for data processing and chart compilation skills.

The objectives are:

- Introducing the fellows to the skills and techniques required to compile accurate nautical charts, containing information and detail essential to the mariner for safe navigation.
- Showing the importance of identifying safety critical features.
- Introducing the fellows to basic navigation, bringing an essential awareness of how charts are used and an appreciation of the wider implications of promulgating hydrographic data. To include elementary navigational mathematics and methods of visual/electronic position fixing.
- Providing the fellows with the underpinning knowledge of the specialist support/processes needed in the production and maintenance of navigational charts.
- Introducing the fellows to digital compilation procedures.
- Introducing the fellows to international standards for Electronic Navigational Charts.
- Providing the fellows with the underpinning skills and knowledge to produce and maintain Electronic Navigational Charts.

#### 4.1.1 Assessment standards

To achieve the minimum training standard in each Module of the course, achieving an average pass mark of at least 50% on each Module.

All fellows were formally assessed during the course through tests and assignments undertaken at the end of each module. Students were informed of the criteria before each assignment.

A certificate stating successful completion of the Category B course was presented to all who completed the programme satisfactorily.

Students received ongoing feedback during the course to enhance development and to prepare for formal assessments.

#### 4.2 The course

The course delivered was the UKHO's internationally IHB/FIG/ICA accredited Cat B programme in Marine Cartography and Hydrographic Data Processing. The course is delivered in 4 defined Modules with a final project over a 16-week period.

The course is highly practical and enables delegates to demonstrate knowledge and aptitude through a series of progressive exercises and assignments, and through examinations. The course supports the IHO Category B standard through demonstration of learning through skills, knowledge and attitudes. The course aims to support a range of learning styles, is interactive and encourages participation.

Formative and summative assessments were carried out throughout the course, with feedback provided to individuals and to the group.

The course was delivered by the UKHO International Training Team, and supplemented by presentations given by UKHO specialist speakers, and visits to

related work areas. This helps place the learning into context and adds value to the learning.

Additionally, field trips were undertaken to the following authorities to enable the delegates to gain an understanding of chart usage, data gathering, national and port responsibilities.

The visit from Rear Admiral Mustafa Iptes, Captain Alberto Costa Neves and Mr Naohiko Nagasaka was very well received by all. It gave the fellows encouragement and was appreciated by the training team. The presentations made by Rear Admiral Mustafa Iptes and Alberto Costa Neves on the role and responsibilities of the IHO were also very welcome and reinforced to the delegates the important role they all have.

This was once again a truly international collaboration and supports the ethos of the IHO and NIPPON Foundation in developing capacity, improving standards, and in developing an international cartographic community to enable continuous professional development.

A number of weekend visits and trips were organised by the training team to show the fellows areas of local interest in the region. The aim of these trips is to allow the fellows to interact in an informal setting and is always well received by the group.

Yeovilton – Fleet Air Arm Museum Exeter – City tunnels North Devon – Lynton & Lynmouth Wells, Glastonbury & Clarkes Village Bristol – SS Great Britain Bath – Cathedral & Christmas Market Cardiff Cheddar Gorge and Caves

On the 9<sup>th</sup> October the fellows attended World Hydrography Day held at Trinity House, London. This was a prestigious event attended by the IHO Council, the Minister of State for Defence and representatives from the fellow's embassies. The evening provided the Students with the opportunity to explain the value of the NIPPON course and capacity building to the hydrographic community to a wider audience.

The fellows were also kindly invited by R Adm Tim Lowe and his wife Lynda to their home for a pre-Christmas informal drinks function which was thoroughly enjoyed by the group.

#### 4.3 Results

All of the fellows proved themselves to be very committed and worked in a diligent manner to achieve and exceed the standard required of each Module. The effort, hard work and commitment shown to succeed was exemplary and all fellows participated fully in classroom discussions. The fellows adapted well to the culture and working environment.

The delivery of the course content by a data centric method of delivery has enabled the students to concentrate on the process of developing the necessary skills through the course culminating in a final summative assessed project. The final project provides an opportunity for the learning that has been undertaken to be consolidated, linking the foundational cartographic skills and knowledge covered in all of the modules to the production and maintenance of the finished product.

The selection process has again proved to be vindicated with all delegates repaying the faith shown in them by the selection committee and by their own organization in nominating them.

This group of fellows have proved themselves to be exceptionally talented individuals who have grasped the principles of cartography and applied them in the classroom environment, asking appropriate questions and applying themselves with enthusiasm and commitment to the role of being a cartographer.

An overall assessment of each student was carried out, and fed back to them at the end of the course. This assessment will be sent to each of them and to their respective managers.

The Final Certificates, including the NIPPON Fellowship certificate were presented by Rear Admiral Tim Lowe, CBE, UK National Hydrographer, at the closing ceremony.

#### 5. Course Evaluations

The course was fully evaluated both during and at the end of course. The students were all given the opportunity to feedback to the trainers every two weeks on how they had progressed and identified any issues which could be resolved and reviewed. This feedback enables the students to have direct input into their own learning, and can help resolve any concerns or issues.

An end of course evaluation was completed by the students (see Annex A). This final evaluation reviewed the whole programme including; administration, management, training delivery and social events. Free text questions allowed the students to comment freely on the programme, enabling them to highlight any issues or areas they wished to expand upon.

A 3-month evaluation will be implemented to review how learning has transferred to their respective organizations.

#### 6. Finance/ Review of expenditure

It was agreed that the NIPPON Foundation would fund the programme to the total of €194 514

The UKHO also committed funds to cover additional expenses related to entertainment/social events. This is an important element of the students stay, and ensures that they get a wider experience during their stay. It helps bond the group, and enables students to get to know UKHO staff outside of their normal work environment. These relationships can play an important role during and post course.

A daily allowance is given to the students, and is sufficient to enable them to support themselves during meal time and weekends.

The generosity of the NIPPON Foundation in supporting this course is very much appreciated, and it is now important that such investment is measured in real terms through transfer of learning into each student's organization. The evidence from previous courses demonstrates that there has been a real return on the investment made and I'm sure that this will continue with this group.

#### 7. Conclusions

This course was once again an honour for the UKHO to deliver, thanks to the generosity of the NIPPON Foundation, and the support provided by the IHO Secretariat and JHOD.

It was a major commitment for the UKHO International Training team but one that proved to be a rewarding experience. To deliver such a programme (16

weeks) not only required great commitment from the training team, but also, and especially, from the delegates.

The selection process for this programme, and the criteria set, proved to be well defined resulting in a high calibre of delegate. Their attitude from day 1 was exemplary, their willingness to learn, to apply themselves, to undertake the exercises given without question, and to support the training team so willingly was a credit to the group as a whole. The evaluations submitted also support the generosity of spirit, and their willingness to provide constructive comment.

There are of course lessons to be learnt, and the feedback gained from both students and trainers will be applied to ensure the course progresses and that the students stay continues to be a rewarding one in the future.

What is now important is that the investment made by all parties in ensuring this course was a success, is that the learning gained will now be applied back in the student's respective organizations.

The feedback provided by previous courses shows that this course is not only well received and appreciated but also having a real tangible impact on individuals and organizations.

A follow up 3-month post course evaluation will take place to identify how the learning has transferred for each student. This will provide real evidence of the benefits of the programme. Ultimately it is hoped that students through provision of evidence will be able to be recognised through a Certificate of Proficiency via a learning log.

Additionally, there will undoubtedly be some intangible benefits, as RAdm Mustafa Iptes said in his speech to the students, "they are all ambassadors of the IHO" and have a responsibility to share their knowledge and continue to communicate with each other. Creating such an international community and network will encourage continuous professional development, and this kind of communication has already been evident from previous courses. The NIPPON Fellowship has also supported the ethos of the NIPPON Foundation in creating a "human network to support knowledge sharing".

I would personally like to thank the NIPPON Foundation for their generosity and support, the UKHO for their support, and to the IHO Secretariat for their support and encouragement.

#### 8. Evaluations

The post course evaluation from the fellows provided evidence that the experience was a positive one, the joining instructions were well received, the accommodation provided was good, the fellows indication the standard of training and the standard of support was excellent and all indicated that the knowledge gained would put into practice upon their return to their offices.
