## PROPOSAL TO HOLD AN EXTRAORDINARY SESSION OF THE INTERNATIONAL HYDROGRAPHIC CONFERENCE IN 2000

Dear Sir,

Decision No. 11 of the XVth I.H. Conference established Terms of Reference for the work of the Strategic Planning Working Group [SPWG]. It also required the SPWG to make recommendations concerning the need for a Special Conference to approve the Report of the SPWG, and the new IHO Strategic Plan.

In IHB Circular Letter 44/1998, the SPWG asked Member States to note March 2000 as a provisional date for the Special Conference. It advised that this recommendation would be confirmed after the Member States had returned their comments on the draft Strategic Plan, which was attached to the Circular Letter.

Nine responses from Member States have been incorporated into the draft Strategic Plan and Work Programme. No substantial changes arose from these comments.

The SPWG, by a majority decision, has now recommended that an extraordinary Conference should be held in March 2000 (Annex A). The main items to be discussed should be the adoption of the new Strategic Plan and Work Programme, and such other recommendations of the SPWG Report which require decisions by the Member States.

The SPWG considers that, as the IHO moves into a new era, the strategic directions of the Organization and the structural adjustments required to achieve the objectives, should be agreed by the Member States in Conference. The subject is too important to be dealt with by correspondence.

The Directing Committee supports the views of the SPWG.

The cost of this extraordinary conference has not been included in the budget for the period 1998-2002 approved by the XVth I.H. Conference. However, the Directing Committee considers that the additional expense can be managed within the approved figures.

In accordance with the Convention on the IHO, Article VI, the Directing Committee now proposes to Member States that an extraordinary Conference should be held in Monaco in March 2000.

An outline of the programme for the proposed extraordinary Conference is attached herewith in Annex A.

Member States are requested to complete the voting paper attached at Annex B, and to return it to the IHB **before 30 June 1999**. Approval of the proposal requires at least 31 votes in favour by the due date [see Convention Article VI, paragraph 1].
