UPDATE CONCERNING SITUATION OF PENDING MEMBER STATES

Reference: IHB CL14/2003 dated 10 February 2003

Dear Hydrographer,

I am pleased to provide you herewith the latest situation concerning those countries whose applications for membership of the IHO are still pending.

A. Countries whose application for membership has been approved but which have not yet deposited their Instrument of Accession:

BULGARIA's application was approved on 24 April 1992; **MAURITANIA**'s application was approved in February 1991 and **QATAR**'s application was approved on 11 November 1993. The IHB will communicate once again with these countries in order to establish their intentions to deposit their Instrument of Accession.

To date none of the Governments of the above-mentioned countries have deposited their Instrument of Accession with the Government of Monaco.

B. Countries which have not yet obtained the required approval (countries are listed in alphabetical order):

1. **LATVIA** applied for membership on 5 July 2002 (CL29/02 refers) and at present has obtained 36 approvals out of a required 46.

2. **MAURITIUS** applied for membership on 20 August 2001 (CL38/01 refers) and at present has obtained 35 approvals out of a required 44.

3. **ROMANIA** applied for membership on 10 April 2002 (CL18/02 refers) and at present has obtained 32 approvals out of a required 45.

4. **SAUDI ARABIA** applied for membership in September 2002 (CL43/02 refers) and at present has obtained 29 approvals out of a required 47.

The Directing Committee would naturally like to see the IHO membership process speeded up, and would therefore be very grateful to IHO Member States if they could actively encourage their Governments to approve the above four pending applications. Please find in the 4 annexes to this Circular Letter, the list of IHO Member States who have already approved the membership of the 4 pending countries mentioned above. Thank you for your cooperation.
