8TH WEND MEETING, 5-6 MARCH 2004, TOKYO, JAPAN

WEND/8 Resolution on Fostering ENC Production and Availability Observers to WEND Chairman and Vice-Chairman of WEND

Dear Hydrographer,

1. The 8th Worldwide Electronic Navigational Chart Database (WEND) Committee meeting was hosted by the Hydrographic & Oceanographic Department of the Japan Coast Guard in Tokyo, Japan, on 5-6 March 2004, under the Chairmanship of Rear Admiral K.R. Srinivasan, India. Over sixty representatives of 27 Member States and, for the first time, observers from non-governmental organizations and professional associations deliberated on numerous issues of importance relating to the production and distribution of Electronic Navigational Charts (ENC). The full proceedings are summarized in the minutes that can be found on the IHO website (www.iho.shom.fr > Committees > WEND). A list of actions arising from this meeting is in **Annex A**.

2. A significant focus of the meeting was on the issues of coverage, consistency, availability and user-friendliness of ENCs. These issues, in aggregate, contribute to the limited use of ECDIS as a navigation system satisfying the carriage requirements of Regulation 19 of SOLAS V and impede the improvements in safety of navigation and efficiency in maritime operations that may be realized with the worldwide use of ECDIS. Several measures were introduced to highlight these concerns and improve the state of affairs.

3. An ENC production "cookbook" and ENC encoding recommendations to improve consistency are nearing completion and will be made available to Member States. The definitions of Regional ENC Coordinating Centers (RENC) and "Integrated Services" have been clarified. A high level briefing paper suitable for discussions with government officials at ministry level is under development. This briefing paper will make clear a government's obligation to provide modern navigational information and detail the benefits of ENCs and ECDIS.

4. Continued efforts are required in implementing assistance programs or cooperative agreements in order to expeditiously achieve worldwide availability of ENCs. Regional Hydrographic Commissions (RHC) must be the focal point for identifying training, equipment and capacity needs of their Member States, for recommending initiatives to address these needs and for setting a prioritized production schema and timeline for ENCs within their regional waters. User-

friendly availability of ENCs requires individual Member States and RHCs to assess the need to establish new RENCs or align with existing RENCs to ensure ENC consistency and efficient distribution to the mariner.

5. In **Annex B** you will find a copy of a WEND Resolution approved at the 8th WEND meeting. It requests that Member States and Regional Hydrographic Commissions take certain actions to accelerate ENC production and improve ENC availability. RHCs are requested to report the status of these measures to the IHB. The IHB will directly communicate with RHC Chairmen and RHC corresponding members of the WEND Task Group to focus this input.

6. As noted above, observers were admitted to the proceedings for the first time. The Committee noted that the WEND Terms of Reference (TOR) do not provide for the attendance of observers while the CHRIS TOR do. With the recent additions to the WEND Principles to include user-friendliness and other customer oriented perspectives, the attendance of industry organizations – especially the shipping industries – seemed appropriate. Furthermore, the SPWG has formulated criteria whereby international Non-governmental Organizations (NGO) can apply for accreditation as observers to the IHO. As a result, the Committee tasked the IHB to circulate to MS, for approval, the following additional item to the WEND TOR to allow international NGO to participate as observers in WEND meetings:

"The Committee may invite accredited international NGOs and professional associations to participate as observers to Committee meetings."

The current WEND TOR are reproduced in **Annex C**. It is suggested that the new proposed item be included as Rule of Procedure 2.2 (subsequent items would be re-numbered accordingly). Member States' approval is sought by completing the response form in **Annex D**, to be returned to the IHB **by 15 September 2004**.

7. Reflecting Action Item 12 (see Annex A), Member States are urged to expedite the process of approving pending applications for IHO Membership.

8. Rear Admiral Srinivasan has informed the Bureau of his forthcoming retirement after 37 years of naval service. On behalf of the IHO and the WEND Committee the Bureau thanks Admiral Srinivasan for his valuable service and guidance, especially as the WEND Chairman for the last two sessions. **Annex E** solicits Member States' to nominate a representative for the WEND Committee and possibly as WEND Chairman and Vice Chairman. Member States are kindly requested to provide this information to the IHB **by 15 September 2004**.

All remaining actions for the IHB are being attended to, or will be in the near future. The 9th WEND Meeting has been planned at the IHB on 7-8 April 2005, i.e. immediately before the 3rd Extraordinary International Hydrographic Conference (11-15 April).

WEND RESOLUTION

The WEND Committee, at its 8th session,

- *Considering* the insufficient coverage with official ENCs in several regions,
- *Being concerned* about inconsistencies of official ENCs both within some regions and amongst different regions, potentially causing confusion with the mariner,
- *Noting* that current official ENC services often are patchy, heterogeneous and not sufficiently user friendly,
- *Noting* that the present problems with availability and user-friendliness of ENC services may adversely affect the acceptance of ENCs by the mariner for the use of ECDIS in navigation,
- *Being also concerned* that the slow uptake of official ENCs by the marketplace may jeopardise the goals to improve safety and efficiency of navigation pursued by IMO and IHO with introducing ECDIS as a navigation system satisfying the carriage requirement of SOLAS V/Reg 19 when used with official ENCs,
- *Recognising* the obligation of Coastal States under SOLAS V/Reg. 9 to provide hydrographic services and to produce nautical charts which results, in conjunction with Reg. 19, in a corresponding obligation to produce official ENCs,

Resolves,

- (a) Where MS are not yet fully involved in ENC production:
 - 1. IHO Members States are encouraged to work together in the Regional Hydrographic Commissions (RHCs) to speed up ENC production, e.g. through *bilateral or multilateral assistance programmes, or seek cooperation* with any member HO offering training and/or production capacities on conditions to be mutually agreed,
 - 2. RHCs should develop, where not yet existent, ENC production schemes and time schedules for the ENC production *for small scale coverage and prioritised routes and ports*, and should report the details to IHB as soon as possible;
- (b) Where MS have already developed ENCs, but are not yet affiliated to an existing RENC:
 - 1. IHO Member States are requested, where they have ENCs already produced but not released for public use yet, to make them available in compliance with SOLAS V, Reg. 9 and 19, and to facilitate inclusion with integrated services,
 - 2. *RHCs* are asked in their region to *achieve a maximum degree of quality assurance and user-friendliness of services* in compliance with the WEND Principles, and to cooperate to this purpose with each other or with other HOs, e.g. by forming an own RENC, or by seeking the services of existing RENCs, and to inform IHB as soon as possible of the measures they have implemented, or are planning to implement.

WORLD-WIDE ELECTRONIC NAVIGATIONAL CHART DATABASE (WEND) COMMITTEE

TERMS OF REFERENCE

Objective:

To promote the establishment of a World-wide Electronic Navigational Chart Database (WEND) suitable for the needs of international shipping.

1. Terms of Reference

- 1.1 To provide a forum for the coordination of the activities of Member States in achieving the objective.
- 1.2 To harmonize the policies of regional ENC Coordinating Centres (RENC) with respect to matters related to administration, legality, finances, technical processes, etc.
- 1.3 To take account of the Terms of Reference of, and consult with, other IHO bodies as appropriate, particularly CHRIS.
- 1.4 To report to Member States annually through Circular Letter and make a report to the ordinary sessions of the International Hydrographic Conference.

2. Rules of Procedure

- 2.1 The Committee is composed of representatives duly authorized by Member States and an IHB Director will attend WEND Meetings.
- 2.2 Meetings shall be held once a year. The venue and date will be announced at least three months in advance.
- 2.3 The Committee Members will elect the Chairman and the Vice-Chairman of the Committee at its first meeting following each ordinary session of the International Hydrographic Conference.
- 2.4 Recommendations of the Committee will be submitted to the IHO Member States for adoption through the Directing Committee.
- 2.5 The IHB will serve as the Secretariat for the WEND Committee.
