### 17th CHRIS MEETING Rostock, Germany, 5-9 September 2005 including ECDIS Stakeholders' Forum, 6-7 September

#### Dear Hydrographer,

The final minutes of the 17<sup>th</sup> CHRIS Meeting held in Rostock, Germany on 5-9 September 2005, as well as all documents referred to at this meeting, are available on the CHRIS page of the IHO website¹ (www.iho.shom.fr > Committees > CHRIS). Also included is a summary report of the ECDIS Stakeholders' Forum which took place on 6-7 September in conjunction with CHRIS/17 (Annex J of the Minutes). The Meeting attracted 44 delegates from 24 Member States and was chaired by Captain Robert WARD (Australia). A list of actions arising from this meeting, with their current status, is provided in **Annex A**. Member States' attention is drawn to the following main points:

#### Future of S-57 (Section 5.1 of the Minutes)

The main item on the agenda was to determine the future development of the IHO Transfer Standard for Hydrographic Data (currently S-57 edition 3.1) and its associated ENC Product Specification. There is a need to maintain the IHO data transfer standard as a contemporary standard and also to allow for necessary improvements to ENCs for use in ECDIS. An ECDIS Stakeholders' Forum was convened during the CHRIS meeting specifically to canvass the widest possible opinion and views on the future of S-57 before reaching any conclusions and to ensure that the CHRIS was fully informed of possible impacts as part of its deliberations. The outcome of the CHRIS considerations on S-57 has since been promulgated in IHO Circular Letters in references a) and b).

## Terms of Reference (Section 4.2 of the Minutes)

The CHRIS reviewed its Terms of Reference and those of its subordinate bodies, particularly to include recognition of Non Governmental International Organizations (NGIOs) as agreed at the 3<sup>rd</sup> Extraordinary International Hydrographic Conference (3<sup>rd</sup> EIHC, April 2005). As a result, revised Terms of Reference for CHRIS were submitted to Member States by Circular Letter in reference c). No objection to the new TOR was received at the Bureau and they are therefore **accepted**. We thank the eight Member States who explicitly expressed their support of these TOR, i.e. Chile, Greece,

Netherlands, Norway, Peru, Portugal, Spain and United Kingdom. Peru further mentioned an editorial mistake in the Spanish version of the TOR, which has been corrected accordingly.

#### Future of CHRIS (Section 4.3 of the Minutes)

As a result of the agreement in principle to proposals submitted to the 3<sup>rd</sup> EIHC concerning reorganisation of the main bodies of the IHO, CHRIS considered how the Committee might migrate to become the proposed Hydrographic Standards and Specifications Committee (HSSC). The CHRIS Chairman subsequently submitted a report to the IHO Strategic Working Group (SPWG) for consideration in due course.

## Work Plan of CHRIS subsidiary bodies (Section 6 of the Minutes)

The work of all the CHRIS Working Groups and sub WGs was reviewed. As a result the CHRIS Work Plan was amended and endorsed. Concern was expressed over the level of participation in some WG's, in particular the Colours and Symbols Maintenance Working Group (C&SMWG) and the Standardisation of Nautical Publications Working Group (SNPWG). In both cases, IHO Member States' participation is low and there is a pressing need to attract wider technical participation from "expert contributors" from industry and academia to supply expertise not available from MS.

The 18<sup>th</sup> CHRIS Meeting will take place from 25 to 29 September 2006 in Cairns (Queensland), Australia, at the kind invitation of the Australian Hydrographic Service. It is planned for the next session of the ECDIS Stakeholders' Forum to take place in conjunction with the 10th meeting of the WEND Committee, which will normally be during the week 11-15 September 2006 at the IHB (dates to be confirmed).
