3rd MEETING OF THE HYDROGRAPHIC SERVICES AND STANDARDS COMMITTEE (HSSC) 8-10 November 2011, IHB, Monaco

Reference: CL 86/2010 dated 10 December - HSSC, 2nd Meeting, Rostock, Germany, 26-29 Oct 2010

Dear Hydrographer,

- The 3rd meeting of the Hydrographic Services and Standards Committee (HSSC-3) will take place from **8-10 November 2011 at the International Hydrographic Bureau, Monaco**. HSSC-3 will be preceded by a meeting of the HSSC Chair Group on the afternoon of 7 November. In addition to the Chair, this will comprise the chairs of HSSC Working Groups (WGs), plus the vice chair and secretary of HSSC, and the relevant IHB director. Delegates' attention is drawn to the closing time for the meeting 1700 on Thursday 10 November. In the circumstances, delegates are recommended to commence their return journey on the following day.
- This letter provides information on the current status of actions arising from the 2nd HSSC meeting (Rostock, Germany, 26-29 October 2010); and sets out a draft agenda for HSSC-3.
- <u>Venue and Accommodation</u>. The meeting will be held in the IHB conference room. Logistics information, such as details of available hotels, and a registration form for HSSC-3 have been posted on the IHO website (http://www.iho-ohi.net/mtg_docs/com_wg/HSSC/HSSC3/HSSC3Docs.htm). Registration forms for HSSC-3 should be submitted to the Secretary by 15 September 2011.
- 4 <u>Actions arising from HSSC-2</u>. The status of all actions arising from HSSC-2 are summarized in **Annex A**. Some actions are still pending. Those nominated for actions that remain outstanding are kindly requested to take action as necessary and report the status to the Secretary of HSSC at mhuet@ihb.mc as soon as possible.
- 5 <u>Draft Agenda for HSSC-3</u>. A provisional agenda for HSSC-3 is provided in **Annex B**. Associated documents, where known, have been listed. Member States are kindly requested to review the draft agenda and provide any comments or proposals for new agenda items to the Secretary, **by 30 June 2011**. If necessary, a revised draft agenda will then be prepared and published on the IHO website.
- 6 <u>Submission Deadline for HSSC-3 Documents</u>. Documents intended for consideration at HSSC-3 should be submitted to the Secretary in accordance with the "<u>Instructions for the Submission of Reports and Proposals for Consideration by HSSC</u>", as follows:
