CIRCULAR LETTER 64/2012 26 June 2012

TONNAGE FIGURES, NUMBER OF SHARES AND VOTES

References: IHB CCL09/2011 dated 16 June

Dear Hydrographer,

- During the XVIIIth International Hydrographic Conference (IHC) the Directing Committee informed Member States that the revised table of tonnage figures, number of shares and votes, due to enter into force on 1st January 2013, could not be finalized for the approval of the Conference in accordance with Article 6 of the Financial Regulations. This was due to various Member States not providing the updated figures of their tonnages as requested in reference mentioned above or any follow up reminders.
- The Conference agreed with the proposal of the Directing Committee, not to proceed with the approval of the table at the Conference, but to allow time to communicate with those Member States that had not yet provided their tonnage figures and to develop a final table for approval, before the 1st July. It was also agreed that for those Member States that do not provide updated tonnage figures, Resolution R2.1 will be applicable, based on the tonnages reported by the Lloyd's Register of shipping for 2011. The Directing Committee has now sent specific letters to those Member States that had not responded to CCL No. 9. Some Member States have responded, others not. For those Member States that have not provided updated tonnage figure Resolution R2.1 has therefore been applied.
- The attached Annex lists the finalized tonnage figures, number of shares and votes that will enter into force 1st January 2013. It is provided for the approval of Member States. Member States may subsequently amend their tonnage figures as they appear in the attached table by giving at least six months notice, in accordance with Article 6 (d) of the Financial Regulations.
- 4 Member States are requested to fill in the attached voting form and return it to the Bureau no later than Monday 20th August 2012.
