NEW DIRECTING COMMITTEE - ALLOCATION OF RESPONSIBILITIES

Dear Hydrographer,

1. The new Directing Committee, comprising Mr. Robert WARD, President and Mr. Mustafa İPTEŞ and Mr. Gilles BESSERO, Directors, will assume office on 1 September 2012.
