OUTCOME OF THE FOURTH MEETING OF THE INTER-REGIONAL COORDINATION COMMITTEE (IRCC4)

Reference: CL 25/2012 dated 20 February 2012 – CBSC10 and IRCC4

Dear Hydrographer,

- 1. The fourth meeting of the IHO Inter-Regional Coordination Committee (IRCC4) was held in Singapore on 7-8 June 2012, kindly organized by the United Kingdom Hydrographic Office (UKHO) in cooperation with the Maritime and Port Authority of Singapore (MPA). The meeting was chaired by Ingénieur général de l'armement Gilles BESSERO (France) and attended by the Chairs, or their Representatives, of all Regional Hydrographic Commissions, relevant Committees, Sub-Committees, except WWNWS, and delegates from nine individual IHO Member States.
- 2. The main items on the agenda of the Committee were:
 - the status of approval of the Protocol of amendments to the IHO Convention
 - the status of the IHO membership
 - the outcome from the XVIIIth International Hydrographic Conference (IHC)
 - the inputs and reports from the IRCC Bodies
 - the IRCC Work Programme management.
- 3. The final minutes of IRCC4, together with all documents referred to at the meeting, are available in the IRCC Section of the IHO website. The list of actions arising from the meeting together with their current status and the list of IRCC Tasks for 2013 are provided in the Annex to this letter. The most significant points discussed at the meeting are summarized below.
- 4. Status of approval of the Protocol of amendments to the IHO Convention.

The Committee reviewed the list of Member States which had not yet ratified the Protocol of amendments and invited RHCs to aim at securing the additional ratification by a minimum of 12 Member States as soon as possible and no later than the end of 2013 so that the first Assembly may take place in 2014.

5. Outcome from the XVIIIth IHC

The main topics related to IRCC arising from the XVIIIth IHC that were discussed at the meeting were:

- the review of the CB Strategy, that is to be reported back to the 5th EIHC
- ways and means of enhancing C-55
- the implementation of the WEND principles
- the IHO Work Programme and Strategic Planning Mechanism
- the development of MSDI.

6. Development of WEND.

The Committee discussed the documents prepared by the WENDWG that were presented to the XVIIIth IHC and the Conference decision to send PRO WENDWG-2 (Implementation of the WEND Principles) Annexes B and C back to the WG for further consideration at its next meeting. The Committee agreed various actions regarding the monitoring of WEND and the provision of feedback to stakeholders in general, and IMO in particular.

7. Implementation of the IHO strategic planning mechanism.

The Committee noted that the Conference had agreed that the Directing Committee should work with the two Committees (HSSC and IRCC) to review the strategic performance indicators set out in the annex to document CONF.18/WP1/Add.2 before submission to Member States for their approval and to invite the HSSC and IRCC to review the operational performance indicators relevant to them and report back to the 5th EIHC. The Committee agreed on a limited set of basic and representative Working Level Performance Indicators (WPIs) suited to the IRCC component of the IHO 2013-2017 Work Plan and on a monitoring framework.

8. CB Strategy.

The Committee noted that the Conference had tasked the CBSC to review the IHO CB Strategy focussing on IHO objectives and to consider the financial implications, and to report to the 5th EIHC. The Committee tasked the CBSC Chair to report the revision of the IHO CB Strategy to IRCC5.

9. FIG/IHO/ICA International Board on Standards of Competence (IBSC).

The IBSC Chair reported on the increasing number of programme submissions and recognitions, including the first regional scheme for individual recognition from the Australasian Hydrographic Surveyors Certification Panel (AHSCP). The Committee also noted the evolution of the revision of the Standards (S-5 and S-8) and publications C-6 and C-47, and the two new members who had recently joined the IBSC.

10. IRCC achievements.

The Committee reviewed its activities and outputs since its establishment in 2007 and established a list of achievements attached to the report of the meeting.

11. Election of Chair and Vice-Chair

The Committee elected Dr. Savithri Narayanan (Canada) and Rear Admiral Nick Lambert (UK) as Chair and Vice Chair of the IRCC for the period 2012-2017.

12. Next meeting.

The 5th IRCC meeting (IRCC5) will be held on 3-4 June 2013 in Wollongong, Australia, hosted by the Australian Hydrographic Service. Representatives of Member States who may require a visa are advised to submit their applications well in advance.
