## THIRD MEETING OF THE WORLDWIDE ENC DATABASE WORKING GROUP (WENDWG3) 13-14 May 2013, IHB, Monaco

Reference: CL 78/2012 dated 10 August – Request for input to the guidelines for the implementation of the WEND Principles
