# IHO-IAG ADVISORY BOARD ON TECHNICAL ASPECTS OF THE LAW OF THE SEA (ABLOS) - IHO REPRESENTATIVES

Dear Hydrographer,

- According to its Rules of Procedure, the IHO-IAG Advisory Board on Technical Aspects of the Law of the Sea is composed of four representatives from IHO and four from the International Association of Geodesy (IAG). The term of membership is for a period of four years and may be renewed. The current membership of ABLOS is listed in Annex A.
- The IHB has been advised that Commander Muhammad BASHIR, former Deputy Hydrographer of Pakistan and member of ABLOS since 2007, has retired and that his seat on the Board is now vacant.
- 3 Dr. Zvonko GRZETIC, Hydrographer of Croatia, has acknowledged that his duties are constraining his ability to participate as actively in the work of ABLOS as he would prefer and he has expressed a wish to revert to participating as an observer, in accordance with article 2.3 of the ABLOS Rules of Procedure. His position as a member of ABLOS is therefore also vacant.
- 4. Member States are requested to consider nominating suitable experts to fill the two vacancies, by completing the nomination form in Annex B and returning it to the IHB by **30 April 2013**. Member States should take into consideration that the selected experts are expected to be supported and funded by their parent organization for travel expenses and availability to participate actively in ABLOS meetings and tasks.
- 5. The Directing Committee will examine the nominations and either select the new ABLOS members, in liaison with the ABLOS Chairman, Prof. Sunil BISNATH, Canada, or, should there be more than two nominations, put forward the names of the candidates for a vote by Member States.
- 6. The Directing Committee takes this opportunity to express its appreciation to Commander Muhammad BASHIR and Pakistan for their valuable contributions to ABLOS activities and to Dr. Zvonko GRZETIC and Croatia for their continuing involvement.
