Hydrographic Services and Standards Committee (HSSC)

Dear Hydrographer,

- 1. The 6th meeting of the Hydrographic Services and Standards Committee (HSSC-6) will take place from 11 to 14 November 2014, kindly hosted by the Hydrographic Office of Chile (SHOA) in Viña del Mar, Chile.
- 2. This letter provides information on administrative details, the current status of actions arising from HSSC-5 (Shanghai, China, 5-8 November 2013 see reference), and sets out a draft agenda and timetable for HSSC-6.
- 3. Participation in HSSC-6 is open to all IHO Member States, and up to two delegates each representing Observer States and International Organizations accredited by the IHO.
- 4. <u>Venue and Accommodation</u>. The meeting will be held at the Hotel Marina Del Rey, Viña del Mar. General and logistical information, such as details of available hotels and visa requirements, and the registration form for HSSC-6 have been posted on the IHO website (<u>www.iho.int</u> > Home > Committees & WG > HSSC > Section "Next Meeting" link to "Documents"). The registration form is also available at Annex D.
- 5. Attendees should book their chosen hotel at their **earliest convenience**.
- 6. Registration forms for all delegates intending to participate in HSSC-6 should be submitted to the HSSC Secretariat (adcs@iho.int), copy to SHOA (gestion@shoa.cl) by 31 August 2014.
- 7. <u>HSSC Chair Group meeting</u>. HSSC-6 will be preceded by an informal meeting of the HSSC Chair Group in the afternoon of Monday, 10 November. In addition to the Chair of HSSC, this meeting will comprise the Chairs of HSSC Working Groups (WGs), the Vice-Chair and the Secretary of HSSC.
- 8. <u>Actions arising from HSSC-5</u>. The status of all actions arising from HSSC-5 is summarized in **Annex A**. Some actions are still pending. Those nominated for actions that remain outstanding are kindly requested to take action as necessary and report the status to the HSSC Secretariat (adcs@iho.int) as soon as possible.
- 9. **Draft Agenda and Timetable for HSSC-6** is provided in **Annex B**. Associated documents, where known, have been listed. Member States are kindly requested to review the draft agenda and programme and provide any comments or proposals for new or amended subjects to the Secretary, **by 31 August 2014**. If necessary, a revised draft agenda and timetable will be prepared and published on the IHO website.

10. <u>Submission Deadline for HSSC-6 Documents</u>. Documents intended for consideration at HSSC-6 should be submitted to the HSSC Secretariat in accordance with the "<u>Instructions for the Submission of Reports and Proposals for Consideration by HSSC"</u>, as follows:

Delegates are kindly requested to circulate these documents amongst their relevant subject matter experts and consolidate any appropriate comments to allow effective decision making at the meeting of the HSSC rather than deferring decisions for further post-HSSC technical consultations.
- 12. <u>Miscellaneous</u>. The current list of HSSC contacts is provided in **Annex C**. Any changes should be forwarded to the HSSC Secretariat at the earliest opportunity.
- 13. As requested in paragraph 17 of the reference, *Members States are kindly invited to propose venues for the subsequent HSSC meetings to be held in early November 2015 (HSSC-7) and early November 2016 (HSSC-8)*. Proposals are welcome at any time and preferably in advance of HSSC-6.
