OUTCOME OF THE 7TH MEETING OF THE INTER-REGIONAL COORDINATION COMMITTEE -AVAILABILITY OF NEW WORLDWIDE ENC DATABASE (WEND) SERVICES AND RELATED ACTIVITIES

Dear Hydrographer,

1. The seventh meeting of the Inter-Regional Coordination Committee (IRCC-7) took place in Mexico City, Mexico, from 1 to 3 June 2015. The Committee considered the References A and B that are related to the activities of the Worldwide ENC Database Working Group (WENDWG). This Circular Letter reports on the availability of new WEND services that can be used by Hydrographic Offices, Regional Hydrographic Commissions and their International Charting Coordination Working Groups (ICCWG). The relevant decisions and actions arising from the IRCC-7 that affect the activities of the WENDWG and related stakeholders are also highlighted, in accordance with the draft lists of decisions and actions posted on the IHO website that are available at:

2. The IRCC commended the work of the Regional ENC Coordination Centres (RENCs) in supporting the WENDWG and the IHB (IRCC7/Decision 28). In addition to the IHO ENC Catalogue and as proposed by the WENDWG, the IRCC agreed that the RENCs make available a new on-line tool (IRCC7/Decision 29 and Action 57). The "*RENC Coverage and Overlap Checker*" tool is now available for use by the ICCWGs and by the IHB. Using a friendly interface, the tool enables a user to display the coverage of all the ENCs that are distributed through the RENCs and easily identify any overlaps. The use of the RENC Coverage and Overlap Checker tool is intended to provide support for addressing and solving ENC overlap issues. The on-line tool is hosted by PRIMAR and can be accessed at:

4. The IRCC tasked (see IRCC7/Action 59) the IHB to continue the progressive development of the IHO ENC Catalogue within the IHO GIS environment, in accordance with the principles set out at the fifth meeting of the WENDWG (see Reference E) and as reported at IRCC-7 (see Reference F).

5. The IRCC endorsed the proposal of the WENDWG in Reference B that **no further action** should be taken for the moment for amending the *WEND Principles* and the *Guidelines for the Implementation of the WEND Principles* (IRCC7/Decision 31).

6. The IRCC approved the continuation of the WENDWG under its current Terms of Reference (IRCC7/Decision 26) and endorsed its proposed work programme.

7. Decision N° 12 of the 5^{th} Extraordinary International Hydrographic Conference (EIHC-5) which tasked the IRCC:

"...to assess the long term consequences of not achieving full implementation of the WEND Principles."
