CIRCULAR LETTER 01/2016 07 January 2016

STATUS REPORT ON APPROVALS OF AMENDMENTS TO THE CONVENTION ON THE IHO AND ON PENDING APPLICATIONS FOR IHO MEMBERSHIP AND ACCESSION OF NEW MEMBER STATES

Dear Hydrographer,

1. The Directing Committee and staff of the IHB are pleased to take advantage of this first Circular Letter of the year to renew their very best wishes for 2016 to all the IHO Member States and are looking forward to another busy and fruitful year for the International Hydrographic Organization. Below we provide an update on the status of the approvals of the Protocol of Amendments to the IHO Convention as well as of the pending applications from new Member States to the Organization.

Protocol of Amendments to the Convention on the IHO

2. In order for the proposed amendments to the Convention on the IHO to enter into force, the approval of at least 48 existing Member States, being two-thirds of the Member States entitled to vote at the time of the 3^{rd} Extraordinary International Hydrographic Conference (EIHC-3) held in 2005, are required.

3. According to the information provided by the Department of External Relations and Cooperation of the Government of Monaco at the end of 2015, 46 of the required 48 Member State Governments (Algeria, Argentina, Australia, Bangladesh, Belgium, Brazil, Canada, Chile, China, Cuba, Cyprus, Democratic People's Republic of Korea, Denmark, Estonia, Finland, France, Germany, Greece, Iceland, India, Islamic Republic of Iran, Italy, Japan, Republic of Korea, Latvia, Mexico, Monaco, Morocco, Netherlands, New Zealand, Norway, Pakistan, Papua New Guinea, Peru, Poland, Portugal, Russian Federation, Slovenia, South Africa, Spain, Sri Lanka, Sweden, Tunisia, Ukraine, United Kingdom and United States of America) have formally notified their approval of the Protocol of Amendments. Five approvals (Algeria, Argentina, Belgium, India and Ukraine) were recorded in 2015.

4. A list of those Member States that do not seem to have indicated to the Government of Monaco their position on the approval of the Protocol of Amendments to the Convention on the IHO is contained in Annex A.

5. A brief in English, French and Spanish outlining the principal effects of the Amendments is available on the IHO website at <u>www.iho.int</u> > Home > IHO Membership > Protocol of Amendments.

6. The 5th Extraordinary International Hydrographic Conference agreed in Conference Decision No. 2 that "… those Member States that have not yet ratified the Protocol of Amendments to the IHO Convention should do so as soon as possible, in order to facilitate the recruitment of new Member States". The objective to record an additional two approvals in time to hold the first Assembly in 2017 now seems within reach. The Directing Committee intends to take all necessary measures, in liaison with the Government of Monaco and with the relevant Member States, to achieve this goal, building on the initiatives undertaken since September 2012. In all cases, the Directing Committee remains available to brief relevant government or diplomatic staff, particularly those based in diplomatic missions in Europe.

Pending Applications

7. The States listed below, whose membership applications were approved in earlier years, have not yet deposited their Instrument of Accession to the IHO Convention:

<u>Mauritania</u>	(application approved in April 1991)
<u>Bulgaria</u>	(application approved in April 1992)
Sierra Leone	(application approved in September 2010)
<u>Haiti</u>	(application approved in November 2012)

The Directing Committee has continued to be in communication with the authorities of these States to encourage them to complete this final formality.

8. As announced in IHO CLs 32/2015, 62/2015, applications for membership of the IHO were received from Malta, Vanuatu, Congo and the Solomon Islands. To date these pending applications have obtained the following number of approvals: Malta – 25; Vanuatu – 25; Congo – 22; Solomon Islands – 22. A list of those IHO Member States that do not seem to have indicated their position is contained in Annex B.

Accession of New Member States

9. The Directing Committee was delighted to welcome Georgia, Viet Nam and Brunei Darussalam to the IHO (as announced in IHO CLs 30/2015, 33/2015) as full IHO Members bringing the IHO Membership to 85 Member States.

Conclusion

10. The Directing Committee encourages those representatives of Member States that have not yet indicated to the Government of Monaco their position on the approval of the Protocol of Amendments to the Convention on the IHO to actively follow up this matter with their government authorities, identifying any problems that may be present and, if needed, seek the assistance of the Directing Committee.

11. The Directing Committee also encourages those IHO Member States, whose Governments have not yet indicated to the Government of Monaco their position on the approval of the applications for membership made by Malta, Vanuatu, Congo and Solomon Islands to actively encourage their government authorities to consider doing so as soon as possible (see also IHO CL 67/2015).
