HYDROGRAPHIC SERVICES AND STANDARDS COMMITTEE (HSSC) 8th Meeting, 14-18 November 2016, IHB, Monaco

Reference: IHO CL 02/2016 dated 8 January - Outcome of the seventh Meeting of the

Hydrographic Services and Standards Committee (HSSC)

Dear Hydrographer,

1. The 8th meeting of the Hydrographic Services and Standards Committee (HSSC-8) will take place from 14 to 18 November 2016 at the IHB, in Monaco.

- 2. This letter provides general information on the meeting and sets out a draft agenda and timetable.
- 3. Participation in HSSC-8 is open to all IHO Member States, and up to two delegates each representing Observer States and International Organizations recognised as observer organizations by the IHO.
- 4. <u>Venue and Accommodation</u>. The meeting will be held at the IHB, 4b Quai Antoine Ier, Monaco. General and logistical information, such as details of available hotels and visa requirements, have been posted on the IHO website (<u>www.iho.int</u> > Home > Committees & WG > HSSC > Section "Next Meeting" <u>Documents</u>). Delegates requiring any assistance are invited to liaise with the HSSC Secretariat at <u>adcs@iho.int</u>.
- 5. Attendees should book their chosen hotel at their **earliest convenience**.
- 6. <u>Registration</u>. It is planned that registration will be available online via a link in the HSSC-8 section of the IHO website ((Home > Committees & WG > HSSC > Section "Next Meeting"). The link will be available **from 15 June 2016**. A registration form will be available at the above web address for those delegates that are not able to register on line. All delegates intending to participate in HSSC-8 should register by 15 September 2016.
- 7. HSSC Chair Group meeting. The plenary meeting will start on 15 November and will be preceded by a meeting of the HSSC Chair Group in the afternoon of Monday 14 November, from 1400 to 1700. In addition to the Chair of HSSC, this meeting will comprise the Chairs of HSSC Working Groups (WGs), the Vice-Chair, the Secretary and the Assistant Secretary of HSSC. If the Chair of an HSSC WG cannot be present at the HSSC Chair Group Meeting and/or at the HSSC Meeting, they are requested to make appropriate arrangements (through the Vice-Chair, Secretary or a representative of any IHO Member State) for the WG to be represented and to inform the HSSC Secretary accordingly.
- 8. Actions arising from HSSC-7. The current status of actions arising from HSSC-7 (Busan, Republic of Korea, 10- 13 November 2015 see reference), is available on the IHO website (www.iho.int > Committees & WGs > HSSC > HSSC-7 > Post Meeting Documents [Actions...] (Link)) or directly as Document HSSC8-03B (Link). Some actions are still pending. Those nominated for actions that remain outstanding are kindly requested to address them and report the status to the HSSC Secretariat at (adcs@iho.int) as soon as possible.

- 9. **Draft Agenda and Timetable for HSSC-8**. A draft agenda and timetable for HSSC-8 is provided in **Annex A**. Associated documents, where known, have been listed. Member States and Observers are kindly requested to review the draft agenda and programme and provide any comments or proposals for new or amended subjects to the HSSC Secretariat **by 31 August 2016**. If necessary, a revised draft agenda and timetable will be prepared and posted on the IHO website. Delegates are invited to note that the meeting is expected to continue until 1600 on Friday 18 November and are advised to plan their travel arrangements accordingly.
- 10. <u>Submission Deadline for HSSC-8 Documents</u>. Documents intended for consideration at HSSC-8 should be submitted to the HSSC Secretariat in accordance with the "<u>Instructions for the Submission of Reports and Proposals for Consideration by HSSC</u>", as follows:

- 11. All documents will be posted on the IHO website (Home > Committees & WG > HSSC > Section "Next Meeting" Link) as and when they are received. Delegates are kindly requested to circulate these documents amongst their relevant subject matter experts and consolidate any appropriate comments to allow effective decision making at the meeting of the HSSC and avoid, as far as is practicable, the need to defer decisions to allow further post-meeting technical consultations.
- 12. <u>Miscellaneous</u>. The current list of HSSC contacts is kept updated on the IHO HSSC webpage (<u>Link</u>). Any changes should be forwarded to the HSSC Secretariat (<u>adcs@iho.int</u>) at the earliest opportunity.
- 13. According to the arrangements outlined at HSSC-7, the 9th HSSC meeting is planned to be held in Ottawa, Canada from 6 to 10 November 2017 and the 10th HSSC meeting, in Rostock, Germany in 2018. Proposals for hosting subsequent meetings to be held in 2019 (HSSC-11) and 2020 (HSSC-12) are welcome at any time and preferably **not later than at HSSC-8**.
