CALL FOR COMMENTS ON DRAFT NEW EDITION 1.0.0 OF IHO PUBLICATION S-8A – STANDARDS OF COMPETENCE FOR CATEGORY "A" NAUTICAL CARTOGRAPHERS

Dear Hydrographer,

1. Task 3.3.9 of the 2013-2017 IHO Work Programme authorised the FIG/IHO/ICA International Board on Standards of Competence for Hydrographic Surveyors and Nautical Cartographers (IBSC) to develop separate competency requirements for Category "A" and Category "B" Hydrographic Surveyors and Nautical Cartographers (see Reference A). As announced in References B and C, the IHO adopted revised versions of the Standards of Competence for Category "B" and then Category "A" Hydrographic Surveyors (IHO Publications S-5B and S-5A).

2. In accordance with the IBSC work programme which was endorsed by the Inter-Regional Coordination Committee (IRCC) at its eighth meeting in Abu Dhabi, in May 2016 (see Reference D), the IBSC is now developing a similar set of separated Standards of Competence for Nautical Cartographers at the Category "A' and "B" levels. Reference E called for comments on the draft new edition 1.0.0 of IHO Publication S-8B *Standards of Competence for Category "B" Nautical Cartographers* and the feedback received was considered by the IBSC and a new draft will soon be available for consultation in the IHO website.

3. In accordance with Reference F, the Chair of the IBSC has requested the IHO Secretariat to circulate a draft new edition 1.0.0 of S-8A - *Standards of Competence for Category "A" Nautical Cartographers* seeking comments from Member States and stakeholders.

4. Both draft editions 1.0.0 of S-8B and S-8A will be considered by the IBSC at its 40th meeting (IBSC40 - Wellington, New Zealand, 20-31 March 2017) and then submitted to Member States for approval, subject to the endorsement by the IRCC at its 9th meeting (Paramaribo, Suriname, 12-14 June 2017).

5. In order to maintain the original timetable for the adoption of the new standard by mid 2017, the IBSC Chair has submitted a request in his report to the Assembly to authorize the IRCC to seek Member States' approval by correspondence through the Secretariat. This would avoid the delay that will otherwise occur because of the requirement to seek the endorsement of the Council that will by then be established but will not meet until October, prior to seeking Member States' approval.

6. Similar to S-5A and S-5B (References B and C), the new editions of S-8A and S-8B will be supplemented by the companion document - *Guidelines for the Implementation of the Standards of Competence for Hydrographic Surveyors and Nautical Cartographers*. This document is intended to assist educational and training organizations in the preparation of submissions to the IBSC in relation to the relevant Standards of Competence. The document was developed by the IBSC from the current *Guidelines for the Implementation of the Standards of Competence for Hydrographic Surveyors* in order to refer to the four Standards and is also available for consultation with the draft edition of S-8A.

7. In accordance with the process of consultation required under Reference F, the draft edition of S-8A is now available (*in English only*) on the IHO website at:

8. Member States are invited to review the draft and to provide their comments on the first draft edition 1.0.0 of S-8A to the IHO Secretariat at cl-lc@iho.int. Training and Education Institutions recognised by the IBSC are also invited to provide their comments. The deadline for comments is <u>20</u> <u>March 2017</u>.

9. Subject to the approval of a new edition of S8-A and S8-B by the Member States by mid 2017, institutions seeking recognition of their nautical cartography programmes by the IBSC in 2018 (at the IBSC41 meeting) will be expected to submit their programmes based on the new Standards S-8A and S-8B.
