REVIEW OF THE ARRANGEMENTS FOR THE MONITORING OF INT CHARTS

Dear Hydrographer,

- 1. The adoption by the IHO Member States of Edition 3.0.0 of IHO Publication S-11 Part A *Guidance for the Preparation and Maintenance of International (INT) Chart and ENC Schemes* was announced in Reference A. This new Edition extended the scope of S-11 Part A in order to incorporate guidelines for the preparation and maintenance of small and medium scale ENC schemes; and align the Publication with the modernized S-11 Part B *International Chart Web-Catalogue* and associated on-line web services. The document was also restructured to accommodate these changes, and reformatted as separate English and French versions rather than a bilingual document.
- 2. Decision 2.4 of the 5th Extraordinary International Hydrographic Conference (Reference B) tasked the Inter-Regional Coordination Committee (IRCC) to review arrangements for the collection and examination of INT Charts and to consider the need to amend or develop relevant IHO Resolutions. As a result, a procedure incorporating a basic check-list for reviewing INT charts, developed by the Nautical Cartography Working Group (NCWG) and Regional INT Charts Coordinators, was agreed at IRCC-7 and implemented on a trial basis. On the basis of the experience gained so far, the IHO Secretariat proposed to the IRCC at its 9th meeting to revoke IHO Resolution 1/1992 *Monitoring of INT Charts* and to incorporate the new procedures in Section 100 of S-11 Part A. The proposal was

endorsed by the IRCC (Reference C – Decision 45). The Hydrographic Services and Standards Committee (HSSC) endorsed the changes to Edition 3.0.0 of S-11 Part A proposed by the NCWG by HSSC Letter (see Reference D) and tasked the HSSC Chair to submit the revision to the IHO Council for endorsement, under the arrangements that are now in force as a result of the ratification of the Protocol of Amendments to the Convention on the IHO; and following the establishment of the Council by the first session of the IHO Assembly (see Reference E - Decision No. 26).

- 3. At its 1st meeting in October 2017, the IHO Council endorsed the revision of S-11 Part A and deletion of Resolution 1/1992, and tasked the IHO Secretariat to circulate draft revision 3.1.0 of S-11 Part A to IHO Member States, for their consideration and approval (see Reference F Decisions C-1/20 and C-1/26 and Action C-1/21).
- 4. The proposed revision 3.1.0 of S-11 Part A and a marked up "redline" version are now available on the IHO website at: www.iho.int > Standards & Publications > Draft Publications Awaiting Approval by Member States (*English version only*).
- 5. Member States are requested to take into account the endorsement of the IRCC, the HSSC and the IHO Council and to consider the adoption of the proposed revision 3.1.0 of S-11 Part A and deletion of Resolution 1/1992 by providing their reply on the Voting Form in Annex A, at their earliest convenience and **no later than 05 January 2018**.
