FINANCE COMMITTEE CIRCULAR LETTER 2/2004 17 May 2004

APPROVAL OF THE REPORT OF WORKING GROUP OF THE FINANCE COMMITTEE ON SALARY ALIGNMENT WITH THE UNITED NATIONS SYSTEM

Reference: FCCL 5/2003 dated 17 October 2003

Dear Hydrographer,

In the referenced Finance Committee Circular Letter (FCCL) the Directing Committee sent the Report of the Working Group of the Finance Committee (FCWG) that was established, according to the Decision 21(a) of the XVI International Hydrographic Conference, with the aim to study the alignment of the salaries of the IHB Directors and other Staff with the UN system.

In the reference letter the Directing Committee, after discussing the Report with the Chairman and Vice Chairman of the Finance Committee highlighted the main topics, indicated the needed increase of the approved level of expenditures for the period 2004-2007 for the implementation of the proposed recommendations, specified how the money will be available for 2004 and for 2005 and for the subsequent years, and noted that two-thirds majority of all Member States is needed for the approval of the increased expenditures. The Directing Committee and the Finance Committee Officers made it clear that increases in the share value above those currently approved in the Five Year Budget during the XVI International Hydrographic Conference, are not envisaged for this specific issue.

The IHB is grateful to the fifty Member States who responded to this FCCL. Forty seven are in favour and three against as indicated in the attached Annex. Therefore Member States have approved the report with the recommended increase in the level of expenditures for 2004-2007.

The Directing Committee will amend the Staff Regulations according to the recommendations proposed in the Report of the FCWG and will revise Chapter one of the 2004 Budget in order to reflect the approved level of salaries from 1st July.
