Madame la Directrice, Monsieur le Directeur,

1 La 1^{ère} réunion du Comité des services et des normes hydrographiques (HSSC-1) aura lieu du **22 au 24 octobre 2009, à Singapour**. La réunion HSSC-1 sera tenue immédiatement après la 3^e conférence internationale sur les ECDIS (voir www.ecdis09.com) qui se déroulera du 19 au 21 octobre, au même endroit. Une réunion du groupe directeur du HSSC, comprenant tous les présidents des GT du HSSC se tiendra dans l'après-midi du 21 octobre.

2 Le HSSC a été créé le 1^{er} janvier 2009 dans le cadre de la nouvelle structure des comités de l'OHI. Le HSSC a en effet accepté un rôle élargi qui était auparavant dévolu au Comité sur les besoins hydrographiques pour les systèmes d'information (CHRIS). La 20^e réunion finale du CHRIS s'est déroulée en octobre 2008. Cette lettre donne des informations sur la situation actuelle des mesures qui découlent de la 20^e réunion du CHRIS (Niteroi, RJ, Brésil, 3-7 novembre 2008) et propose par ailleurs un projet d'ordre du jour pour la HSSC-1.

3 Lieu et hébergement. La réunion HSSC-1 et la conférence sur les ECDIS se tiendront au Regent Hotel (voir www.regenthotels.com/singapore). Les renseignements sur l'hôtel et un formulaire d'inscription à la réunion HSSC-1 ont été mis en ligne à la section HSSC du site web de l'OHI (www.ihb.int → Committees & WGs → HSSC). Ils sont également fournis dans les **Annexes A et B**, respectivement. Les participants doivent faire leurs réservations d'hôtels, eux-mêmes, dans les meilleurs délais. Les formulaires d'inscription à la réunion HSSC-1 doivent être remis avant le **30 août 2009**.

Un projet d'ordre du jour révisé sera ensuite préparé et publié sur le site web de l'OHI.
