### 15. Other Business

### a) Six Nation Group

It was suggested that simular initiatives be taken for other areas including the Baltic.

Technically it was said to be dangerous to extrapolate an algebraic polynomial formula as the errors became enormous.

### b) New Zealand Department Programme

Major changes had taken place in New Zealand land and hydrographic structures as a result of an improved economy. There is greater social awareness in Governmental.

"Land Information New Zealand" is the new department to give effect to this. A ten-year programme for hydrography has been developed.

LOS aspects will also be dealt with by the new development. A contract for seismic surveys of Northern New Zealand could be entered into shortly.

A desk-top study to determine the requirements for a C/S claim could be funded soon and those consultants are being sought during the Conference.

#### c) Russian Federation

Their HO is also in the process of re-organization and will be transferred from the Department of Defence to a Civilian Department.

### d) Japan

Has requested at the last ABLOS meeting in New Zealand Dr. Katsura has prepared a paper on Continental Shelf determination in an active margin. This is intended to assist other States with active margins and could be circulated within IHO (IAG and IOC?)

It was suggested that "Altimetry" and "Bathymetry" could be used in a desktop study to determine a programme. Japan had considered this but felt unsuitable. New Zealand had also considered this and thought that the costs were low for such methods.
