
## **CB MANAGEMENT SYSTEM REPORT**

#### 1. Introduction

CBSC8 (2010) agreed on Action 8 (Norway, Australia, Chairman, IHB) to draft "technical specifications for the Management Plan model, Consultancy funds to be requested from the IHB".

Norway presented document CBSC9-08.1C Database Management to handle the CB Project by means of Procedures 1 to 5. The basic flow can be seen below:

# INTERNATIONAL HYDROGRAPHIC ORGANIZATION CAPACITY BUILDING SUB-COMMITTEE (CBSC)

CBSC9 (2011) agreed on Action 7 to the Chair to "invite IHB to find a solution for the implementation of the Management Plan Model developed by Norway, approved by the CBSC and considered a vital tool to support the administration of the projects supported by the CBFund".

In September 2011 the CBSC Secretary visited the Norwegian Hydrographic Service (NHS) to continue the development of the specification for the Database Management.

## 2. Development

The specification developed by the NHS was a comprehensive document to contract the implementation of Procedures 1 to 5 and corresponding Database.

However, the experience gained at the IHB on CB Management indicated the need to further develop the system.

Several other information and capabilities are necessary to the proper management of the IHO CB tasks, not included in the current version. For example:

- a) CB Fund management
- b) CB Finance report procedure (IHB ongoing process with Auditors)
- c) CB Procedure 6 development and inclusion
- d) CB Course Candidate Submission procedure (IHB development)
- e) Student follow on procedures and databases
- f) IBSC databases (institutions, programmes, certificates, evolution)
- g) IBSC standares and publications
- h) IBSC Fund management
- i) Performance indicators (strategic and working level)
- j) Risk management
- k) Model courses database development
- I) Link to Member States Database (in development)
- m) Link to IHO GIS (in development)

- n) Link to IHO, CBSC and IBSC Calendars
- o) Link to IHO Work Programmes (annual and 5-year)
- p) Online developments and specifications

An overall view of the CB Management Plan can be seen in the Annex.


#### 3. Future actions
