1. Introduction / Background

Chartwise Training Ltd is a company aimed at providing CB training and consultancy for developing HOs and looking for opportunities to contribute to the IHO CB Strategy.

The Director, Keith Swan, has 39 years experience in paper chart and ENC production and maintenance with the United Kingdom Hydrographic Office (UKHO) and the South African Navy Hydrographic Office (SANHO). He is also a qualified Trainer with training experience to FIG/IHO/ICA recognized Cartography programme at Category “B” level and trained 100s of cartographers form across the world.

2. Analysis/Discussion

The CBWP is demanding and some of the work items are not completed as planned. Chartwise Training Ltd has capacity to provide additional capacity building services to the Hydrographic community to fill gaps where appropriate in a cost effective and timely manner with specialisation in the nautical cartographic field.

Overview of training and consultancy activity

Training:

- Foundation courses
- Advanced courses – to same level as Category “B” recognition
- On the job training
- Training For Trainers

Consultancy:

- QC/QA Quality Management Systems – in line with ISO9001 standard
- Capture/encoding policy guidance
- Technical guidance for production and geospatial issues

Scope of potential contributions

Chartwise Training has access to trainer and consultants who possess a variety of skills, experiences and specialisms in nautical cartography. The main specialism is Training For Trainers which was originally developed by the Director and is designed to enhance individual HO in house training skills.

Appendix A contains a list of outstanding CBSC activities/events/projects for which Chartwise Training would be able to deliver either independently or in collaboration with a partner such as a larger HO or an industry business.

Training courses are flexible and we can deliver standard established training as well as bespoke courses to suit any particular organisations requirements. Further, there are two important aspects of the training cycle that Chartwise Training can offer.

1. Training Needs Analysis (TNA) or a Consultancy Package Analysis (CPA)

We have developed comprehensive and easy to follow questionnaires (see example of a section of a TNA questionnaire in Appendix B). These questionnaires would be sent out and returns analysed at no cost to the HO. However, it is appreciated that for some developing nations this type of information gathering may not be appropriate, where this is the case alternative TNA methods would need to be considered.

Similar types of questionnaires have been developed for a remote ‘first stage’ consultancy and analysis of the HOs requirements.

2. Post course cost benefits analysis

Another important aspect of the training cycle is a post course cost benefit analysis to establish the cost verses benefits. On request from any of the stakeholders we can conduct a comprehensive post course analysis to advise stakeholders of the actual benefits gained. This would be particularly relevant if blended learning is utilised.

Blended learning

E-learning and blended learning is becoming more widely used in many industries with successful outcomes. Chartwise Training is proposing to make greater use of e-learning as part of future blended learning courses and are keen to collaborate where possible with other organisations such as IMarEST who have been investigating e-learning potential or the CBSC. 3. Conclusions

Chartwise Training has access to skilled trainer and consultant resource to deliver solutions to a variety of events within the CB Plan.

Chartwise Training offers upfront Training Needs Analysis and Consultancy Package Analysis free of charge and will on request conduct a cost benefits analysis.

There is an initiative to collaborate e- and blended learning with IMarEST.

4. Recommendations

The CBSC to recognise Chartwise Training has extra capacity building training resources to assist with the CB Plan.

The CBSC to encourage MSs, Chairs of HCs and CB Co-ordinators to engage with the Chartwise Training where there may be a nautical cartographic training shortfall.

5. Justification and Impacts

Chartwise Training has carto training and consultancy resource for the HO community in support of the CB strategy, currently this resource is available at short notice.

Developing cartographers would receive their planned training requirement in a timely manner thus HOs can better prepare for SOLAS V9 and V4, to handle changes in data management and develop MSDI capability.

Upfront Training Needs Analysis and Consultancy Package Analysis could be conducted at no cost to IHO, HOs or industry agency. A Training Needs Analysis conducted by Chartwise Training would ensure the right level and the right material is delivered to the right people. Similarly, where a Consultancy Package Analysis is conducted would ensure the consultant delivers cost effective advice and guidance.

Funding the actual training delivery or consultancy would need to be resourced, it has been noted that some HCs also request funding for trainer's attendance. We are a small independent organisation with few overheads.

If requested a cost benefits analysis may be conducted post course or consultancy at no cost to IHO, HOs or industry agency.

6. Action Required of CBSC

The CBSC is invited to:

- a. Take advantage of Chartwise Training Ltd capacity for providing training and consultancy for the IHO, HCs and HOs.

- b. agree to inform RHCs, via IRCC of the services Chartwise Training Ltd can offer.
- c. note:
 - i. that cartographically skilled and experienced trainers are available at short notice to assist with the CB Plan
 - ii. the availability of a Training Needs Analysis and a Consultancy Package Analysis which bears no cost to the receiving HO or agency.
 - iii. potential collaboration on e- and blended learning with IMarEST.
