1. Meetings

- 1.1 CSPCWG5, 18-21 November 2008, held in Sydney, Australia.
- 1.2 Planned CSPCWG6, 1-3 December 2009, to be held at IHB, Monaco.

2. Work Programme

- 2.1 The programme is based on the priorities assigned within the detailed Work Plan (Annex B refers). Since CHRIS20, the principal activities have been:
- 2.1.1 S-4 (formerly designated M-4) Chart Specifications of the IHO and Regulations for International (INT) Charts:
 - Edition 3.006, published April 2009, included fully revised sections of B-450 to B-479 and other approved changes as follows:

(Part B = IHO Chart Specifications for national and INT medium- and largescales):

- B-312.4 Revised specification for charting mangroves (IHO CL 71/2008 & 20/2009).
- B-412 Clarification of Rounding Rules for soundings and drying heights (IHO CL 20/2009)
- B-434 Additional paragraph on term 'Recommended' (IHO CL 71/2008 & 20/2009)
- B-450 to B-479 Revision covers aids to navigation: fog signals, beacons, buoys and lights. (IHO CL 71/2008 & 20/2009).
- Part B: fully revised sections B-480 to B-499 drafted covering Radio/Radar Aids, Marine Services and Signal Stations distributed to IHO Member States for approval (IHO CL55/2009 requires MS responses by 5 November 09).
 - Part B: a new section B-600 on 'chart maintenance' is in preparation and has reached its 3rd round of consultation within CSPCWG.

2.1.2 INT 1, INT 2 & INT 3:

- INT 1 subWG consists of WG members DE, ES and FR + Secretary. Ongoing detailed correspondence is principally concerned with:
 - whether any differences in symbols between versions could be confusing to the chart user
 - possible transfer of 'aquaculture' symbols to section L
 - possible removal of sections G and O, being replaced by an extended index/translation of terms section.

Summary conclusions will be presented to CSPCWG6, December 09.

2.1.3 Chart specifications, symbols and abbreviations:

- The following new and revised specifications are currently under consultation within CSPCWG:
 - B-381 Revised specification for bridges (showing bridge supports and bathymetry under bridges)
 - B-418 New symbol proposal for unsurveyed areas
 - o B-443.8/444.5 New symbol proposal for pipeline tunnel entrance
 - B-445.2 New specification for platform with superstructure removed
 - B-445.12 New symbol and specification for wave energy devices
 - B-447.4 New symbol proposal for shellfish beds
 - B-471.8c Use of abbreviation FFI (Fixed and Flashing) light.

2.1.4 S-49 Recommendations concerning Mariners' Routeing Guides:

A completely revised version of the former S.P. No 49 has been prepared by the S-49 subWG, under the leadership of Germany. To be submitted for MS approval late 2009.

2.1.5 <u>M-15 List of Booklets on Chart Symbols and Abbreviations Published by</u> Various Maritime Countries

Following a review of its utility and value, M-15 has been discontinued (IHO CL 105/2008 & 23/2009).

2.1.6 Provision of Advice:

Chairman and Secretary continue to provide responses to a variety of miscellaneous enquirers, including requests for advice from regional INT Chart coordinators and RHCs.

3. Progress on CHRIS20 Action Items

3.1 <u>CHRIS Action 20/23</u>: **Chair of CSPCWG** to develop ToR / RoP for INT Chart Coordinators. Consequently:

Meeting CSPCWG5 agreed to add development of ToR/RoP for INT Chart Coordinators to the CSPCWG Work Plan (Item B2) as high priority. A draft ToR/RoP document was prepared and distributed to Chairman of RCG for comment, 23 July 2009. The result of this consultation process is the paper at HSSC1-06.5B.

3.2 <u>CHRIS Action 20/24</u>: **Chair of CSPCWG** to develop guidelines for preparation &maintenance of small / medium scale ENC schemes. Consequently:

Meeting CSPCWG5 agreed to add development of guidelines for preparation & maintenance of small / medium scale ENC schemes to the CSPCWG Work Plan (Item B3) as medium priority. Unfortunately, no progress has been made to date on this work item.

4. Problems Encountered

- 4.1 Ongoing resource stretch at participating HOs and IHB, including:
 - Timely translation of S-4 revisions into French and Spanish
 - Failure in communications with Cuban representative.

5. Any Other Items of Note

- 5.1 Progress on the revision of S-4 Part B Section 400 is time-consuming due to the detailed nature of the specifications. 3 or 4 iterations of revised drafts are proving to be necessary. UK commits significant resource to support this activity, as do participating HOs in their detailed review of draft technical papers.
- 5.2 The volume of detailed input to CSPCWG's work is extensive and thanks are recorded to all contributor MS' representatives. Typically, 15 MS actively participate in the WG's deliberations. 12 MS (+IHB) attended CSPCWG5 in Australia and a similar number are expected to attend CSPCWG6, in Monaco December 09 CSPCWG members are encouraged to attend.
- 5.3 Additionally, valuable advice is provided by CSMWG and TSMAD Chairs on request, enhancing the collaboration between the WGs. AU's representative (Jeff Wootton) has also been invaluable in providing perspectives across the three WGs and in advising on the consequences of decisions for each.

6. Conclusions and Recommended Actions

- 6.1 HSSC1 is invited to endorse the continued activity of CSPCWG.
- 6.2 CSPCWG's Work Plan was formally reviewed in detail at CSPCWG5, November 2008. An updated version is at Annex B. Following any direction or guidance from HSSC1, this will be subject to further review and revision at CSPCWG6, December 2009.

7. Justification and Impacts

- 7.1 Justification for the continued activity of CSPCWG is to fulfil the remit of its Terms of Reference which includes:
 - Improving the standardization and currency of paper nautical charts;
 - Improving the guidance provided to nautical chart compilers, whatever the product's format, including support for 'Capacity Building';
 - Improving the interface and, where feasible, commonality of presentation between paper and digital chart products, whilst acknowledging their inherent differences.
- 7.2 The principal impact is the resource commitments of participating HOs.

8. Action Required of HSSC

- 8.1 The HSSC is invited to:
 - Note this report.
 - Endorse the Work Plan at Annex B.
