<b>Executive Summary:</b>	This paper presents a "worked example of the use of the templates" which was prepared by Canada (Michel Poulin), as a result of Action Item 3.1 of CHRIS/16. It is proposed to discuss the benefits of these flow diagrams in the light of the already agreed "Guidelines for the submission of reports and proposals for consideration by CHRIS and CHRIS subsidiary bodies".

### Introduction / Background

Action Item 3.1 of CHRIS/16 states:

*3.1 New Zealand and Canada to provide the Secretary with a worked example and clarification of the use of the templates.*

This action refers to Section 5 of CHRIS/16 Minutes "Work of CHRIS", and Annex F "Flow Diagram and Templates for Progress Reports and Change Notes". The following flow diagrams provide worked examples for "A - Change Proposal to CHRIS" (Section 2. of Annex F), "B - Change Note to CHRIS" (Section 3.) and "C - Work Item Status Report to CHRIS" (Section 4.).

### Analysis/Discussion

"Guidelines for the submission of reports and proposals for consideration by CHRIS and CHRIS subsidiary bodies" were agreed at CHRIS/15 (Monaco, June 2003). Slight adjustments / improvements were made to these guidelines by the CHRIS Chair and Secretary in January 2005, as reflected in Doc. CHRIS17-06C. The guidelines include:

- A template that allows M/S to submit new proposals for work items.
- A similar template for WGs to submit additions or changes to existing Work Programmes (via the Chairmen's reports).
- Business rules that set out who should be consulted as part of the decision making process for work items and for resultant standards.

As a result, it is not sure what benefits are provided by the additional documentation and how the flow diagrams help.
