
Principal activities and achievements (1)

 - Future of the paper chart [A16]

 - New and revisited topics considered at NCWG4 included
 - Submarine cables (ICPC)
 - · Satellite derived bathymetry
 - Ballast water management areas
 - Offshore solar parks

 - · Definition of wreck's depth and swept depth over it





 - INT3, Edition 5, 2011 (UK)




Principal activities and achievements (3)

 - See also HSSC11-05.4C

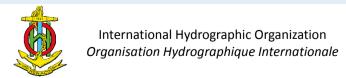


Other items to note: Marine Incidents
