1. Meetings

- 1.1 CSPCWG6, 1-3 December 2009, Monaco.
- 1.2 Chairman attendance at MEDINTCHART meeting 16-17 February, Paris.
- 1.3 INT1 subWG, 16-17 June, Cadiz
- 1.4 Planned CSPCWG7, 23-26 November 2010, to be held in South Africa.

2. Work Programme

The programme is based on the priorities assigned within the detailed Work Plan (Annex B refers). Since HSSC1, the principal activities have been:

- 2.1 <u>S-4 Chart Specifications of the IHO and Regulations for International (INT)</u> <u>Charts</u>:
 - Edition 3.007, published December 2009, included fully revised sections of B-480 to B-497 (completing the revision of section B-400, Hydrography and Aids to Navigation) and other approved changes as follows:
 - B-151 Revised to take account of cancellation TR K1.1 and M-15 (Symbols booklets)

- B-297 Revised ZOC table (derived from supplement 2 of S-57 Edition 3.1)
- Edition 4.000, published September 2010 (CL 49 and 52/2010 refer) included completely new section B-600 (Chart Maintenance and NM System) and other approved changes as follows:
 - B-122 Additional International abbreviations DG, FAD, MRCC
 - o B-381.5 and -B-381.6 New specifications for bridges
 - B-418.1 Additional symbol for unsurveyed areas
 - B-443.8 New symbol and specification for cable in a tunnel
 - B-444.5 New symbol and specification for pipeline in a tunnel
 - B-445.2f New specification for abandoned and disused platforms
 - B-445.12 New symbols for wave energy devices and wave farms
 - o B-447.4 New symbol for shellfish beds

Note: Consequent on publication of B-600, the existing section A-400 will need revising (see new item A.9 in Work Plan).

2.2 INT 1, INT 2 & INT 3:

- INT 1 subWG consists of WG members DE, ES and FR + Secretary.
 Meeting convened in Cadiz principally to resolve differences between the three official INT1 versions and S-4.
- Current editions available on IHO website:
 - French language version of INT 1 published by France 2006
 - Spanish language version of INT 1 published by Spain December 2007
 - English language version of INT 1 published by Germany January 2008
 - Trilingual version of INT 2 published by Netherlands 2007
 - English language version of INT 3 published by UK December 2005.
- New editions of all official INT1s planned for 2011.

2.3 Chart specifications, symbols and abbreviations:

- The following new and revised symbols and specifications are currently under consultation with Member States:
 - o Various facilities for small craft (leisure) users (CL39/2010 refers).
 - Improved Chart Accuracy note
 - Oscillating Directional lights
 - Floating wind turbines,
 - Intervals between symbols in area limits
 - Size and displacement of symbols
 - Floating waste bins
 - Sub-surface ODAS instruments

2.4 <u>S-11 Part A Guidance for the Preparation and Maintenance of International</u> Chart Schemes

Following discussion at HSSC1, the model TOR / ROP for ICCWG has now been included in S-11 Part A, as Annex C. The resulting edition 2.003 was published March 2010.

2.5 S-49 Standardization of Mariners' Routeing Guides:

A completely revised version of the former S.P. No 49 has been published April 2010 as Edition 2.0 of IHO Publication S-49 - Standardization of Mariners' Routeing Guides (CL33/2010 refers). Thanks due to Germany for leading a subWG to guide this revision.

3. Progress on CHRIS20 and HSSC1 Action Items

<u>CHRIS Action 20/24</u>: **Chair of CSPCWG** to develop guidelines for preparation & maintenance of small / medium scale ENC schemes.

Unfortunately, little substantive progress has been made to date on this work item.

HSSC Action 1/24: **IHB/CSPCWG Chair** to incorporate ToR / RoP for Regional International Charting Coordination WGs, as contained in HSSC1-06.5C, in S-11 Part A, taking account the comments made by the committee.

Completed. (CLs 86/2009 and 23/2010 refer).

4. Problems Encountered

Ongoing resource stretch at participating HOs and IHB.

5. Any Other Items of Note

- 5.1 The volume of detailed input to CSPCWG's work is extensive; typically, 20 or more MS actively participate in the WG's deliberations (a notable increase from last year). Thanks are recorded to all contributor MS' representatives. 15 MS (+ IHB) attended CSPCWG6 in Monaco.
- 5.2 Additionally, valuable advice is provided by DIPWG and TSMAD Chairs on request, enhancing the collaboration between the WGs. AU's representative (Jeff Wootton) has also been invaluable in providing perspectives across the three WGs and in advising on the consequences of decisions for each.
- 5.3 CSPCWG now has two industry representatives (ESRI and Jeppesen).
- 5.4 Chairman and Secretary continue to provide responses to a variety of miscellaneous enquirers, including to regional chart coordinators (eg MEDINTCHART, see 1.2 above).

6. Conclusions and Recommended Actions

- 6.1 HSSC2 is invited to endorse the continued activity of CSPCWG.
- 6.2 CSPCWG's Work Plan was formally reviewed in detail at CSPCWG6, December 2009. An updated version is at Annex B. Following any direction or guidance from HSSC2, this will be subject to further review and revision at CSPCWG7, November 2010.

7. Justification and Impacts

- 7.1 Justification for the continued activity of CSPCWG is to fulfil the remit of its Terms of Reference which includes:
 - Improving the standardization and currency of paper nautical charts;
 - Improving the guidance provided to nautical chart compilers, whatever the product's format, including support for 'Capacity Building';
 - Improving the interface and, where feasible, commonality of presentation between paper and digital chart products, whilst acknowledging their inherent differences.
- 7.2 The principal impact is the resource commitments of participating HOs.

8. Action Required of HSSC

- 8.1 The HSSC is invited to:
 - Note this report.
 - Endorse the Work Plan at Annex B.
