Status Report on IHO Publications on Standards, Specifications and Guidelines

Executive summary: This document provides a brief description of the status of all IHO

publications on standards, specifications and guidelines, under HSSC responsibility, as of October 2014. Following the EIHC-5 discussions, a translation plan of these documents in both official languages is given for the initial consideration of HSSC Members.

Background
