EC-IHO Meeting Update

Background

- Memorandum of Understanding on establishing a cooperation on maritime affairs between the European Commission and the International Hydrographic Organization signed in April 2012 in Monaco (18th International Hydrographic Conference)
- Establishment of an IHO Working Group on EU matters composed of representatives of EU/EEA members of the IHO
- 5 EC-IHO meetings between October 2012 and October 2014



Background

Items of discussions:

- Review of projects of mutual interest (including EMODnet and implementation of INSPIRE through Marine Spatial Data Infrastructures)
- IHO input to the Green Paper on Marine Knowledge 2020
- Identification of initiatives that could address EU requirements and benefit from EU support
 - > European programme of hydrography
 - > European coastal mapping
 - > Vertical reference & chart datum
 - Marine dune dynamics
- => Priorities
 - Support of EMODnet
 - Joint European Coastal Mapping Project



IHO and EMODnet

- IHO objectives:
 - 1) Avoid duplication
 - 2) Promote synergies and the use of best practices
- IHO contribution:
 - 1) The IHO considers the development of EMODnet as the best driver for Marine Knowledge 2020
 - 2) The IHO is committed to support EMODnet in the long term
 - The IHO will provide sustainable operational solutions with appropriate QA/QC and updating mechanisms through current IHO regional structures and approaches
 - 4) The IHO strongly recommends the use of relevant international standards such as ISO, IHO and Inspire compatible standards within EMODnet



IHO and EMODnet

- Way forward to improve IHO-EMODnet synergies:
 - 1) EMODnet = EU Marine Spatial Data Infrastructure
 - Implement appropriate standards, based on ISO and INSPIRE-compatible (including IHO S-100)
 - Establish EMODnet as the marine component of GGIM Europe and GEO Europe
 - Establish a sustainable partnership between EMODnet and EU HOs via the relevant Regional Hydrographic Commissions (=> RHCs to establish a trans-RHC coordination), covering the relevant themes
 - Bathymetry (regional component of GEBCO)
 - > Contribution to other themes (geology, physics, human activities, ...)

Implementation through the preparation of the 3rd EMODnet call for proposals



IHO and EMODnet

- Way forward to improve hydrographic knowledge:
 - 1) Set up an harmonized reporting procedure on the status of hydrographic knowledge in EU waters through the relevant Regional Hydrographic Commissions
 - 2) Assess navigational and non navigational requirements & priorities
 - 3) Elaborate a prioritized survey scheme to address the gaps
 - 4) Investigate potential extension/synergies with other themes (geology, physics, ...)
 - 5) Implement the survey scheme
 - 6) Upgrade the EMODnet products and services with appropriate QA/QC procedures
