# PURPOSE OF THE PLENARY SESSION

2013-2017 – ACHIEVEMENTS OF THE IENWG

- **European HOs better identified by EC as key players for marine knowledge**
- **Elaboration of the proposition of a European strategy for bathymetric data acquisition, welcomed by the EU MPs**
- **IENWG has a seat as an observer in the European expert group for Maritime Spatial planning**
- **Several European HOs are involved in framework programmes on acquisition and usage of bathymetry (coastal mapping project, EMODNET Bathymetry)**
- **Meeting with DG MARE, ENV, RTD, REGIO: first step in order to broaden the European HOs' collective visibility from DG Mare to other DGs**
