## Review of S-127 Version 0.2, Review of revised Data Model components

S-127 Development

Dear colleagues,

The development of S-127 Product Specification is proceeding as scheduled. Your feedback on version 0.1 has been considered and as far as applicable incorporated. A comment form proving the results of the considerations will be provided on the relevant NIPWg site (see next section)

#### Review of S-127 version 0.2

The contractors provided version 0.2 which is now ready for review. All amendments have been made in Track Changes mode to simplify the checks. All files are available on the relevant NIPWG ProdSpec website.

It should be noted that S-127 version 0.2 has not yet been harmonised with S-101. Although the S-101PT is making progress, the current S-101 version is still not finished and cannot be used for harmonisation work.

#### Review of amended data model components

S-127 Version 0.2 should be reviewed and I would like to draw your particular attention to following points:

Because of not being originally part of a Vessel Traffic Service, Ship Reporting System and Local Port Service have been removed from the categoryOfVesselTrafficService enumerates list. They are now separate feature types.

The data models are provided in the S-127-0.2 App\_A DCEG.docx file:

Ship Reporting System Area section 5.25Local Port Service Area section 5.26

It is obvious that appropriate reports could be provided to a VTS. But the VTS acts only as PoC in such cases.

### Provision of new ideas which were too late for version 0.2

If you have new information which should be incorporated into S-127, this is the best opportunity to share your thoughts with the team and upon agreement to incorporate them into version 0.3.
