Workshop in Aalborg, Denmark (25 February to 1 March 2019)**

Dear Colleagues:

1. Denmark has graciously offered to host the next S100WG working week from February 25 to March 1. During this week there will be three meetings with the following schedule:

February 25 – 26:	IHO GI Registry Workshop
February 25 – 26:	S-102 Project Team Meeting
February 27 – March 1:	S100 Working Group Meeting
2. Due to the timing of HSSC meetings and the publication of S-100 Edition 4.0.0, the HSSC Members rejected the endorsement of S-102 Edition 2.0.0. In addition, many members provided additional comments for S-102 during this approval process.
3. In consultation with the S-102 Project Team Lead, the HSSC comments have been incorporated into a new redline version of S-102 (labelled edition 1.1.0). It was determined that a S-102 project team meeting will be held during the S100WG working week to discuss and resolve these comments and any new comments that maybe submitted during the upcoming review period so that Edition 2.0.0 may be submitted to HSSC11.
4. As part of the S100WG working week, the IHO Registry Manager will be holding a two day GI Registry workshop

5. In addition, the S100WG work plan has the following standards that are on target for submission to HSSC11:
 - a. S-97 – Guidebook for S-100 Product Specification Developers
 - b. S-98 – Specification for Data Product Interoperability in S-100 Navigation Systems
 - c. S-121 – Maritime Limits and Boundaries
 - d. S-129 – Underkeel Clearance Management
6. S-97 needs to undergo an additional review as it now includes data quality guidance, any comments will be adjudicated at the S100WG meeting.
7. S-98 has also undergone a review, and the comments to be adjudicated at the S100WG meeting.
8. The S-121 and S-129 Project Teams are in the process of finalizing edition 1.0.0 of their respective product specifications, and will be submitted to the S100WG for approval prior to HSSC submission.

 - b. S-102 Comments: January 11th, 2019
 - c. S- 97 Comments: January 11th, 2019
