Mr. PALMER reported the following items:

- The April US Board on Geographic Names (BGN) Meeting has been cancelled.
- The US BGN's Foreign Names Committee (FNC) is currently conducting a review of its role and manner of conducting business.

MR. CHERKIS reported on his attendance at the GEBCO Guiding Committee and Sub-Committee on Digital Bathymetry (SCDB) meetings held earlier this week at La Spezia, Italy.

Mr. ROBB reported on the recent Marine Geographic Names Workshop held at the Marine Biological Laboratory in Woods Hole. Four attendees of today's meeting were present at the workshop. A general discussion of the subject matter followed. The ACUF Secretary's highest priority action item is to establish an ACUF website. Another action item for ACUF is to continue to seek closer cooperation with SCUFN, specifically through the adoption of a single name proposal form that could be used for both committees. The workshop was well received by the attendees and a follow-up meeting is being planned for September.

- He gave a brief summary of the history of the naming of Bowie Seamount.
