Conference / Assembly Announcement

1. In accordance with Reference A and as announced in Reference B, the XIXth International Hydrographic Conference / 1st Session of the IHO Assembly will be held in Monaco from Monday 24 April to Friday 28 April 2017.

2. The meeting of the Finance Committee and the meeting of the Heads of Delegations will take place on Sunday afternoon, 23 April 2017 at the International Hydrographic Bureau (IHB).

3. The Conference is the most important decision-making body of the IHO (Article IV of the Convention on the IHO), and it is essential that all IHO Member States are represented not only to review the past activities of the Organization, but also to adopt an effective and realistic Work Programme and Budget for the next five years (see Note1).

4. The Provisional Conference / Assembly Programme is provided in Annex A to this Circular Letter.

Possibility of an Assembly

5. In the event that the required majority of Approvals of the Protocol of Amendments to the Convention on the IHO are received by the Government of Monaco before 23 January 2017, the XIXth International Hydrographic Conference will, instead, take place as the First Session of the Assembly of the IHO. Taking into account that 47 of the minimum number of 48 Member States have now formally approved the Protocol of Amendments to the Convention on the IHO (see Reference C), the possibility of the First Session of the Assembly is considered to be very likely. The timetable and format of the Assembly would be generally similar to the Conference, however, there may be some consequential changes required to take into account the new regulations that would then be in force. Any such changes will be notified to Member States and observer organizations as soon as is practicable.

Conference / Assembly Format and Programme

6. The Conference / Assembly will be held in the Auditorium Rainier III in Monaco. Registration will take place all day on Sunday 23 April 2017. Other meetings and events which will be held during the Conference / Assembly period are as follows:

- a. The Finance Committee will meet on Sunday 23 April 2017 from 14:00 to 17:30 at the IHB to review and discuss the finance and budget proposals. Because of the limited space available, it is proposed that a maximum of two representatives from each Member State attend the meeting.
- b. A meeting and briefing intended to be exclusively for the Heads of Delegation of Member States will be held on Sunday 23 April 2017 from 18:00 to 20:00 at the IHB.
- c. The Opening Ceremony for the Conference / Assembly will take place on Monday morning, 24 April 2017. New Member States that have joined the Organization since the 5th Extraordinary International Hydrographic Conference will be invited to present their flag on this occasion.
- d. As usual, Industry and Member States will be invited to mount exhibitions of their work and their activities in two separate areas within the Auditorium Rainier III. The exhibitions will open on Monday, 24 April 2017 following the Opening Ceremony and will remain open until Friday 28 April 2017, closing at 12:00.
- e. The Election of Directors (see Note2) will be held on Friday morning, 28 April 2017.

7. Other meetings involving Member States can be organized during the Conference / Assembly period if required. Chairs of the relevant bodies wishing to convene such meetings are invited to inform the IHB, by 31 December 2016, of their needs in terms of preferred dates and expected number of participants. This will enable the IHB to make the necessary arrangements.

8. The Conference / Assembly will meet in plenary session to examine each of the three reports corresponding to the Work Programmes of the IHO, together with any proposals submitted for the consideration of the Conference/Assembly, including the revision of the IHO Strategic Plan (see Reference D) and the 2018-2022 IHO Work Programme and Budget (see Note3). Any Proposals should refer to one of the three IHO Programmes. Topical issues related to the Programmes may also be considered, as appropriate.

9. Reports will be prepared by the IHB, based on information available to the IHB, and input from the Chairs of the IHO Committees – Hydrographic Standards and Services Committee (HSSC), Inter-Regional Coordination Committee (IRCC) and Finance Committee (FC).

Submission of Proposals to the Conference / Assembly

10. In order to follow the timetable indicated in Rule 14 of the Rules of Procedure for International Hydrographic Conferences, any proposal or related submission for consideration should be submitted not later than 15 August 2016 (see Note 4).

11. All submissions related to the Conference / Assembly will be collated and translated in to the official languages by the IHB, when required, and made available to Member States in both English and French.

Planned Conference / Assembly Circular Letters

12. Annex B contains a list of the Conference / Assembly Circular Letters that are planned to be issued together with target dates for action (see Note 5). Member States are requested to observe the deadlines for replies so that Conference / Assembly preparations can proceed as smoothly as possible.

Member States' Delegations and Registration

13. It is very important for the IHB to know as early as possible the number and names of representatives who will attend the Conference / Assembly in order to facilitate logistics and the configuration of the Conference / Assembly venue. For the first time, registration will be available online via the IHO website (www.iho.int) at:

(Home > International Hydrographic Conference > Registration for Conference / Assembly)

from 1 September 2016 to 1 March 2017. Member States are invited to register as early as possible.

14. Member States that are not able to register online should forward a list of their delegates, specifying the Head of the Delegation, to the IHB (by e-mail: info@iho.int or by fax: +377 93 10 81 40) not later than 1 March 2017 using the Delegates' Registration Form provided in Annex C or the Excelbased form which will be available at the above web address.

15. Please note that passport and visa requirements are the responsibility of each delegate. The necessary formalities must be completed before travelling to Monaco. Any delegates who may require personalized invitations for visa application purposes should contact the IHB. There are no border-crossing formalities between France and Monaco, but visas or other valid entry qualifications will be necessary to enter France.

Hotel Accommodation

16. All participants must reserve their own accommodation. A list of hotels in the area that have been used by delegates in the past is provided at Annex D. Information is also available on the IHB website: *www.iho.int* and through the following web sites for hotel reservations: (*http://www.monte-carlo.mc/index-hotels_monaco-fr.html*) and (*www.booking.com*)

17. Hotel space will be at a premium as there are several other events taking place in Monaco at the same time as the Conference / Assembly. Bookings should therefore be made well in advance of the Conference / Assembly. Member States are strongly recommended to make hotel reservations as soon as possible. Conclusion

18. The Conference / Assembly is the most important decision-making body of the IHO, and it is essential that all IHO Member States are represented to consider the proposals and reports that will be submitted and to adopt appropriate Resolutions. We look forward to seeing you in Monaco for this major event in April 2017.

- 4. The Directing Committee will issue the appropriate adjustments if the revised Convention is approved by the required majority before that date. The Directing Committee intends to issue a "Red Book" in all cases, although it is not required by the Rules of Procedure of the Assembly.
- 5. Additional Assembly Circular Letters may be required, in particular to address the formation of the IHO Council, if the revised Convention is approved by the required majority before 23 January 2017.
