- Associate membership is available to other IHO Members States or States of the region who are non-IHO members, both being signatories of the statutes of the RHC.
- Other States and International Organizations active in the region concerned may be invited by the RHC to participate as observers.

a. Given the likelihood of the possible scenarios, one MS was supported to be first Member State designated for the 1st session of the Council.

ACTION 13 – The identified MS will verify with its authorities to get support and acceptance – this will be reported promptly by the end of June 2016 to Canada as Chair for action with the members.

- b. ARHC MS selection for the Council will be based on:
 - *i.* Rotation of all 5 MS starting in alphabetic order (C, D, N, R and U) with option to opt out and go to the next MS on the list
 - *ii.* Selection process/Statutes to include that the Member State selected to occupy the seat on Council allocated to the ARHC will acknowledge that it will represent the collective interests of the ARHC.
