EAtHC CB overview

Current challenges in CB (WCA sub-region):

- increasing maritime activities in the African sub-region, making urgent to increase hydrographic capabilities;
- the need to improve the maritime geospatial knowledge in the African sub-region;
- To improve the access to relevant training for the sub-region;
- difficulty, in some cases, to put into practice the training received, due to the lack of equipment.

Technical Visit to Liberia (A-11)

E-learning MSI experimentation (P-06)

- An e-learning course is not just the distribution of a “residential” course on Internet.
- Need to experiment how e-learning could improve the access to hydrographic knowledge for the benefit of coastal States.
- Step1: develop e-learning materials based on regular maritime safety information academic course
- First version to be delivered by the end of 2016.



E-learning MSI experimentation (P-06)

- Tutoring is a fundamental component of E-learning
- Provide support and advice to students through:
 - synchronous forums or virtual classes ,or
 - asynchronous interactions
- Step2: Experimental tutored e-learning session
- Tutored session to be set up in early 2017 with a set of voluntary trainees.
