Subject: Invitation to the XI<sup>th</sup> MACHC Meeting

Dear Mr. Noack,

1. First of all, let me introduce myself and the Organization I represent. I'm Vice Admiral PALMER, Director of Hydrography and Navigation of the Brazilian Navy, and the current Chair of the Meso American and Caribbean Sea Hydrographic Commission (MACHC).

MACHC is an organism which works with the International Hydrographic Organization (IHO) with the main purposes of coordinating the safety of navigation within the region of its responsibility and promoting hydrographic development, which means the production and dissemination of Maritime Safety Information (MSI) in general, and hydrographic surveys and maritime cartography in particular. 2. The International Hydrographic Bureau (IHB) has called my attention to the outstanding role the Comisión Centroamericana de Transporte Marítimo (COCATRAM) has the Caribbean Sea and its historical participation at MACHC meetings. The importance of COCATRAM is distinguish once it is estimated that over 30% of the world's crude oil passes through the Caribbean which is home to over 50% of the world's cruise shipping. In addition, the Caribbean endures a hurricane season from June to November; the storms can and do leave a trail of devastation on the islands and their coasts. For these reasons, it is crucial that Countries in the Region undertake hydrographic surveys as and when required, and that they arrange for the compilation and publication of hydrographic data, as well as the dissemination and keeping up to date of all nautical information necessary for a safe navigation.

MACHC will have its XI<sup>th</sup> Meeting next November, from the 8<sup>th</sup> to the 12<sup>th</sup>, in Paramaribo, Suriname. We will be very glad if you, or COCATRAM representatives, may be present and participate with a brief presentation on the COCATRAM activities. The majority of Hydrographic Offices which work within the Region and IHB representatives will be present at this meeting. I'm sure this will be a very good opportunity for the COCATRAM and the IHO community to get better acquainted with one another and begin a partnership with a great potential to make a highlighted difference in the Caribbean Region.

In annex you may find the logistic information and the Registration Form. The Agenda of the Meeting and the corresponding timetable will be provide as soon as it will be ready.

3. Finally I would like to renew my congratulations on the initiative of the cooperation between the COCATRAM and the IHO and offer myself, my staff, and MACHC, to help with any subject that we may be of use.
