

#### 3.A-INT Chart: MBSHC18 Follow-up

MBSHC18-08 (Region F Coord): to circulate a letter to ICCWG Members regarding the INT charts and ENC UB1 scheme presented at MBSHC18

→ Done: Region F ICC Circular Letter 02/2014 & 03/2015

MBSHC18-09 (AII): to comment on the INT charts and ENC UB1 scheme circulated by Region F ICCWG Co-ordinator.

→ <u>Done:</u> Responses from most MS to both CL. Updated draft Region F catalogue posted on the IHO password protected page (kml/excel).

MBSHC18-21: to provide Region F ICCWG Co-ordinator with the limits of the agreed INT charts in the Black Sea and Sea of Azov.

→ <u>Done:</u> BASWG12 report provided by MBSHC Chair (07/01/2015).


MBSHC18-10 (GR/TR): to provide the Region F ICCWG Co-ordinator with a common proposal regarding the co-production of INT3706, INT3710, INT3712 and INT3716.

→ Ongoing.





## **New INT Chart approval (1/2)**



- → 2 new charts (1:25 000 1:50 000) submitted by UA
- → Complete the coverage of INT3884, INT3885 and INT3886
- → UA Proposals disseminated through Region ICCWG CL03/2015
- → UA3405 and UA3506 were approved by Region F ICCWG.



## New INT Chart approval (2/2)




- 1) RO 1.030.09 to cover the access to Sulina harbour (1:30 000)
- 2) UA 3439 would cover the Northern approach (1:50 000)
- 3) RO 1.050.06 to cover the southern approach (1:50 000)
- → All 3 charts approved by Region F ICCWG.





## Aegean Sea scheme (MBSHC18-11 follow up)



- → Cartographic boundary approach presented by GR (MBSHC19-6.5.3)
- → Other Good practices raised: US-CA, Malacca Strait, IHO CL40/2014





#### **Review of Marmara Sea Scheme**




- → 11 charts proposal over Marmara Sea submitted so far.
- → Would complete the INT coastal scheme south to Bosphorus Strait.





## Georgia Coastal & Harbour Scheme


- → GE proposal to take over the production of INT3871, INT3873 & INT3875 submitted at BASWG11 and BASWG12.
- → Decision to wait for GE to become a IHO Member.
- → No comment from RU received so far regarding that proposal.
- → Need to confirm RU agreement with that proposal
- → GE102 and GE104 chart submitted by GE







#### **Occidental Mediterranean Scheme**




- → Several chart proposal adressed
- → Current Coastal scheme not compliant with S-11 Part.A anyway
- → INT scheme to be reviewed by ICCWG.






## INT Chart proposal in Adriatic: Gulf of Trieste

- → MBSHC16 (2009): HR, IT, SI to review initial SI proposal and other advices and, if agreed, shall submit second draft version to the Coordinator.
- → No progress so far on that proposal.
- → Region F ICCWG agreed to withdraw that proposal from the draft catalogue.





## INT Chart proposal from adjacent Regions




- → EG National charts to be considered within Region F INT scheme.
- → Newly produced EG chart SC01 covering Northern Part of Suez channel includes INT3549 insets A&B coverage.





# Implementation of a Region F INT chart GIS database into the future IHO INToGIS webservices



- → New classification to comply with INToGIS data model, now effective
- → A chart proposal recommended by ICCWG and approved by MBSHC remains schemed until it's been produced.
- →All metadata needed to be implemented into the future INToGIS Region F database.





STATUS OF REGION F ENC COVERAGE

#### **ENC: MBSHC18 Follow-up**

MBSHC18-07 (Region F Coord): to prepare a priority list of main harbours without large scale ENC coverage in the region

→ Done: Region F ICC Circular Letters 01/2014 & 01/2015

MBSHC19-12X: RCC to update the regional priority list of main harbours without large scale ENC coverage in the region.

MBSHC18-11 (IT/TR): to provide the Region F ICCWG Co-ordinator with a common proposal regarding the UB1 ENC cells TR100030 and IT100360. 
→ Ongoing.



#### **ENC Coverage status**

#### No Agreed ENC schemes (i.e. UB) approved so far

**UB1:** Review achieved. Over the 6 overlapping cases, few of them can be resolved shortly. Low navigational interest.

→ Contrast between a well established small scale INT scheme (Index 1) and a disparate UB1 scheme.

**UB2-3:** No Review achieved. Difficulty to address overlapping cases due to significant 'domino effect' from UB1 overlaps assessment, despite significant navigational interests.

**UB4-5-6:** High navigational interests with harbours and mooring areas. Less overlapping issues.

→ICCWG Members agreed to focus on those usage bands.

## **Action proposed (1/2)**

MBSHC19-1X: MS to provide the Region F ICC with their a hard copy or online access to their national chart catalogue (end of July 15)

MBSHC19-2X: TR and GR to schedule a bilateral technical meeting in order to provide the Region F ICCWG with a co-production plan for INT3706, INT3710, INT3712 and INT3716 (end of 2015).

MBSHC19-3X: RCC to circulate a letter to ICCWG Members to report back on the decisions made during MBSHC19 regarding INT chart scheme.

MBSHC19-4X: RCC to circulate a letter to ICCWG Members to submit the Marmara Sea scheme under silence procedure (30 sept 2015).

MBSHC19-5X: RCC to send a letter to RU to confirm the status of GE as new producer of INT3871, INT3873 & INT3875 (30 sept 2015).

MBSHC19-6X: RCC to circulate a letter to ICCWG Members to submit the GE102 and GE104 under silence procedure (30 sept 2015).

MBSHC19-7X: GE to liaise with RU and TR regarding co-production of INT3808 and INT3810 and report back to RCC (BASWG13).



## Action proposed (2/2)

MBSHC19-8X: ES, DZ and FR to review the INT scheme over Western Mediterranean and submit a consolidated proposal (MBSHC20).

MBSHC19-9X: EG to provide the RCC with SC01 chart (15th July 2015).

MBSHC19-10X: RCC to review SC01 and to submit it to ICCWG Members for approval, in liaison with Region J ICCWG (1st October 2015).

MBSHC19-11X: ICCWG Members to provide RCC with charts and insets limits (31st July 2015)

MBSHC19-12X: RCC to update the regional priority list of ports and anchorage areas without large scale ENC coverage in the region (MBSHC20).

MBSHC19-13X: Based on the review achieved during ICCWG side-meeting, ICCWG Members to report back to RCC on the resolution of UB1 overlapping cases (End of 2015).

MBSHC19-14X: RCC to report back to MBSHC Chair on the outcome of UB1 overlaps (January 2016).

MBSHC19-15X: ICCWG Members to provide RCC with their production plan for UB4-5-6 (End of 2015).

<u>MBSHC19-16X:</u> New INT Chart Producer Nations to provide INT chart (new productions and editions) to RCC for review 3 months prior to the actual submission.
