1. A corrected version of S-11 Part B Region “J” for their nations INT charts (manually corrected acceptable) to include changes to publication dates, titles etc
2. Updated projection figures for unpublished INT charts
3. Amendments to the scheme listed in S-11 Part B Region “J” they would like considered by the group – in both textural and graphical form.
4. Proposals for ENC cells within the region – limits, usage band, publication schedule. The group can then amend the ENC scheme.
