


Strategic Purpose of S-55

- High profile in UN and IMO as authoritative source of facts of case, including key deficiencies in survey, charting and MSI.
- IMO and IHO considering the application of S-55 within Voluntary Audit Scheme.
- Important tool for IHO/IMO technical visits




S-55 Data-base in February 2007

- S-55 is open source on IHO web-site (www.iho.int).
- Data available for 90% of listed nations and areas.
- Regular update of entries, at least annually, is vital for standing of the database as an authoritative reference.




S-55 Editorial Issues

- States with coasts in more than one RHC e.g. Colombia. Does affect Saudi Arabia (INT Regions I and J).
- Treatment of detached territories; selection carried forward from Edition 1.
- Interpretation and transparency.

Gaps in S-55


- No gaps for INT Region J, although data for some coastal states has been provided by IHO MS charting nations.
- BUT, only 31% of NIOHC entries have been updated within the last 12 months.
- It is requested that NIOHC set an action for all states to update their entries. PR Charting HOs will help.


Exploitation of the Data-Base

- Need to build on interest in IMO to gain support for national hydrographic effort.
- Communication with national shipping community and navies to raise AWARENESS of penalties of inaction.



S-55 Issues from NIOHC Region

- GMDSS fully implemented in only 19% of NIOHC states, and improved communication needed with charting HOs. Urgent action required.
- 69% of NIOHC states have less than 25% of waters within 200m contour surveyed to modern standards. Assistance needed in definition and delivery of prioritised national survey plans. In house and out-sourcing options for surveying to be assessed, including regional approaches.



Remedy: Use S-55 for RHC bids to the IHO Capacity Building Committee

- Use standard RHC Agendas and National Reports. VMT for inputs.
- Update NIOHC CB matrix (Agenda Item 14).
- Bid to IHOCBC by 1 April.
